The PIO-cum-Project Director (PD), DRDA, Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh, found absent consecutively for the second time without reporting the reason for his absence to the Commission in contempt of the notice for hearing issued to him from the Arunachal Pradesh Information Commission (APIC) on 16.02.2026 and 07.05.2026.

Heard the Appellant;

The Appellant stated that the PIO has not yet provided any information to him till today.

Due to absence of the PIO the hearing adjourned today with the following orders;

- i) Issue **Bailable Warrant of Arrest** against the PIO-cum-Project Director (PD), DRDA, Koloriang, Kurung Kumey District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 22nd day of September' 2026 at 2:30 PM.
- ii) To issue order to the Officer-In-Charge, Koloriang Police Station, Kurung Kumey District, for executing the **Bailable Warrant of Arrest** and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **22.09.2026, at 2:30 PM, without fail**, before this court.
- iii) The copy of this **Bailable Warrant of Arrest** be served to the Superintendent of Police, Kurung Kumey District for compliance.
- iv) The copy of this **Bailable Warrant of Arrest** be served to the Deputy Commissioner, Kurung Kumey District for information.
- v) The Appellant to be present in the next date of hearing without fail, failing which the Commission will hear and determine this appeal ex-parte.
- vi) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 22nd day of September' 2026 at 2:30 PM (Evening).
