An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-325/2025

Shri Pegmir Punu -V/S- PIO-Cum-EE, PHE&WS, Raga, Kamle District A.P.

ORDER

The 4th hearing held on 2th June, 2026' related to the APIC_No-325/A//2025. The Appellant Shri Pegmir Punu present, during the hearing, the PIO –cum EE (PHE & WS) Raga Division represented by APIO Shri Dani Tachang JE –cum APIO present with an authorization letter from the PIO.

Heard the Appellant;

The Appellant stated that all the information have been furnished by the PIO except the information pertaining to Sl.No -3(i)(iii) concerning the firm with the proprietor name (s). The PIO has provided the name of the firms who executed the work but the name of owner of the firm have not been furnished to him till now.

Therefore, prayer is made before the Commission to let the PIO furnish the names of the Proprietor of the firm(s) which executed the work. To be particular, the name of the owner of the firm(s) as provided below;

- i) M/s Yari Enterprises.
- ii) M/s Pegmir Enterprises.
- iii) M/s PL Enterprises.
- iv) M/s TDT Enterprises.
- v) M/s Gomi Hardware Enterprises.
- vi) Vishal Pipes limited.

The names of the proprietor of the above mentioned firm(s) be furnished for which he has applied application by clearly mentioning the same in his Form'A.

Heard the representative of the PIO.

The representative of the PIO admitted that the name of the firm(s) that executed work have been furnished to the Appellant but the names of the owners of the firm(s) have not been provided. But assure the Commission that the name of the owner of the 7(seven) firm(s) that executed work shall be furnished to the Appellant on or before the next date of hearing.

After hearing both the parties the Commission hereby order;

- i) PIO to provide the names of the owner of firm(s) that have been given works to execute the said project for which the Appellant has filed the form 'A' application, on or before the next date of hearing and to be present in the next date of hearing without fail, **failing which the Commission will initiate action against the PIO as per provisions of RTI Act 2005.**
- ii) The Appellant to be present in the next date of hearing without fail, **failing which the Commission will presume that he has been provided with all the information and thereby this appeal will be disposed of on the next date of hearing.**
- iii) Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 11th August' 2026' at 2:30 PM
