ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.

2). The 4th hearing was held on 25th August 2026 (Tuesday) at 1100 hrs. Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh appeared before the court through online video conference and the representative of the PIO, Er. Taku Raji, AE-cum-APIO and the Appellant Ms Bengia Mama were present in the court during the hearing.

3).The Commission had directed the PIO and the APIO to convert hard copy information into soft copy and furnish the information electronically in the mail ID of the Appellant or share in her Whatsapp within fifteen days from the date of issue of this order.

4). The Appellant, vide letter dated 28/08/2026 informed the Commission that the PIO had furnished incomplete information. The information sought at Form A dated 24/03/2026 sl.no. 1, 2, 4, 5, 6, 7, 8, 9, 10, 11, 12, 17, 18 & 19 had not been furnished.

5). The Commission directs the PIO to furnish above information as mentioned against the sl.no. of Form A dated 28/8/2026, in case information are not available the PIO should give justifiable reasons in writing to the Appellant under intimation to the Commission before the next date of hearing.

6). **The next date of hearing is fixed on 13th October 2026 (Tuesday) at 11 am.**

7). **Therefore,** Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

8). In case the Appellant is found absent for the hearing the case would be disposed of.

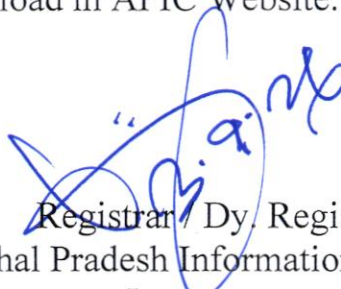
