Information sought:

The appellant has filed an RTI application dated 22.12.2025 seeking following information regarding the issuance of Permanent Resident Certificates (PRCs) to individuals who are holders of PRCs from other districts and have surrendered their original PRCs while applying for PRC in Namsai District.

Details of information required: -

1. Kindly provide information on the present status of my RTI Application bearing my file no. RTI-13/2025 dated the 13.08.2025, which was forwarded to the Joint Secretary

SC/ST Cell, Civil Secretariat, Govt. of Arunachal Pradesh vide letter no. DSJE/14/08/RTI/2025 (Copy enclosed as Annexure-I)

2. Provide the CTC copy of the response/reply by the Department of SJETA, Govt. of Arunachal Pradesh, for the letter bearing No. NMS/JS/T.Jamoh/2025 dated 24th of June 2025 (Copy enclosed as Annexure-II) issued/sent by the Circle Officer (JS) for the Deputy Commissioner, Namsai, District Namsai (AP) which was addressed to the Secretary, SJETA, Govt. of Arunachal Pradesh Itanagar and was received by the office bearing diary No. 263 dated 5th August, 2025 as per office receipt register.
3. Kindly provide information on the present status on the above mentioned letter bearing No. NMS/JS/T.Jamoh/2025 dated 24th of June 2025.
4. Provide the CTC of all the Correspondences/ File noting (Hard file/E-files) pertaining to the letter bearing No. NMS/JS/T.Jamoh/2025 dated 24th June 2025 (as mentioned above).

The following were present.

Appellant

: Present. He states that he has already received the information sought at serial no. 1 in RTI application. The information sought at serial no. 2, 3 and 4 was pertaining to the status of the letter memo no. NMS/JS/T-Jamoh/2025 Dated 24.06.2025 written by Deputy Commissioner, Namsai to the Secretary, SJETA, Govt. of Arunachal Pradesh. Instead of furnishing the status of action taken on the said letter, the matter was complicated by referring the matter to the Director SJETA, Political Department and ST / SC Cell of the Civil Secretariat, Itanagar.

Respondent PIO

: Present. He states that information was already furnished to the appellant but he was not aware of the said letter dated 24.06.2025 of DC, Namsai.

FAA

: Shri Maryi Doyom, JTO cum PIO of Director, SJETA represented.

On interjection the appellant produced a copy of the aforesaid letter dated 24.06.2025 and a copy handed over to the PIO O/o Secretary, SJETA Govt. Of Arunachal Pradesh.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the appellant has already received the information pertaining to serial no. 1 of the RTI application.

The PIO – Deputy Secretary SJETA, Govt. of Arunachal Pradesh is directed to furnish the status of the action taken on the letter dated 24.06.2025 from DC, Namsai in the following form the RTI query sought in RTI application within one week from the date of issue of this order under intimation to this commission:

2. *Provide the CTC copy of the response/reply by the Department of SJETA, Govt. of Arunachal Pradesh, for the letter bearing No. NMS/JS/T. Jamoh/2025 dated 24th of June 2025(Copy enclosed as Annexure-II) issued/sent by the Circle Officer (JS) for the Deputy Commissioner, Namsai, District Namsai (AP) which was addressed to the Secretary, SJETA, Govt. of Arunachal Pradesh Itanagar and was received by the office bearing diary No. 263 dated 5th August, 2025 as per office receipt register.*
3. *Kindly provide information on the present status on the above-mentioned letter bearing No. NMS/JS/T. Jamoh/2025 dated 24th of June 2025.*
4. *Provide the CTC of all the Correspondences/ File noting (Hard file/E-files) pertaining to the letter bearing No. NMS/JS/T. Jamoh/2025 dated 24th June 2025(as mentioned above).*

The appellant shall serve a copy of this order to the PIO, obtain acknowledgement and submit a copy of it to this commission. He shall submit a status of further information received from the PIO within 10 days from the date of receipt

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

Order pronounced in the Open Court of this Commission today this 07th day of August' 2026. Each copy of the Judgement / Order be furnished to the parties.

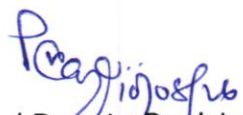
