Shri Bachunum Yun -V/S- PIO-Cum-EE, PWD, Anini, Dibang Valley District, A.P.

ORDER

The 1st hearing held on 26th May' 2026' related to the APIC No-150/A/2026. The Appellant Shri Bachunum Yun is present through online mode during the hearing before the Commission.

The PIO-cum-EE, PWD, Anini Division, Dibang Valley District, Govt. of Arunachal Pradesh is represented by Shri Milo Tade, Assistant Engineer, Anini Sub-Division, PWD, Govt. of Arunachal Pradesh with an authority letter from the PIO.

Heard the Appellant;

The Appellant stated that among the information(s) sought from the PIO and as per the Serial No. of information sought in my Form-A Serial Nos. A, B, C, D, H, I & J only have been furnished to me and Serial Nos. E, F, G & K are still to be provided to him by the PIO.

Heard the representative of the PIO;

The representative of the PIO stated that the PIO has provided the information as sought by the Appellant on 04.09.2025 for the information starting from Serial Nos. A to K of the Form-A of the Appellant, however, the Appellant is insisting that he has not been provided the information for the Serial No. K, which the representative of the PIO submitted before the court that the same information pertaining to Serial No. K will be sent to the address of the Appellant as per the address provided in the Form-A of the Appellant as early as possible.

After hearing both the parties the Commission hereby orders;

- 1) The PIO to provide only the information sought by the Appellant in his Serial No. K of the Form-A on or before the next date of hearing.
- 2) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that he has got the information from the PIO, and thereby, this appeal will be disposed of.
- 3) The PIO to be present in the next date of hearing to ascertain from him whether he has provided the above mentioned information to the Appellant or not, in the failure of the PIO to be present in the next date of hearing the Commission will initiate necessary action against the PIO as provided under RTI, Act, 2005.

- 4) The information provided to the Appellant pertaining to Serial No. K of the Form-A of the Appellant should be appended with a covering letter from the PIO sealed and signed by him and addressed to the Appellant.
- 5) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 4th day of August' 2026 at 2:30 PM (Evening).
