**An Appeal Case U/S 19(3) of RTI Act, 2005**  
**Case No. APIC-654/2025.**

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (RWD), Yazali Division, Keyi Panyor District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.05.2025.

**A. Particulars information:** C/o "Development of wayside Amennities at Tago Putu, Yazali, Keyi Panyor District" during the financial year of 2017-18 under NEC project.

**B. The total List of Project are:**

1. Certified Sanction Order Copy.
2. The certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
3. The certified copy of Utilization Certificate.
4. The certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
5. The certified copy of the criteria of eligibility for CPWD/ APPWD as well as non-CPWD/ non-APPWD contractors in this project.
6. The certified copy of the progress report of the project in physical and financial section till date.
7. The certified copy of completion certificate of the project.
8. The certified copy of the Newspaper in which NIT was published (At least 3 newspaper name (one National & Local) along with date of publication of newspaper, as per Govt. approved order (Order No. IPR/ADVT (Advt. Policy)-37 /2016, dated 30<sup>th</sup> Jan., 2018 by the Secretary to the Govt. of A.P Information and Public relation Department, Itanagar).
9. The certified Desing and Scope of Work in the project.
10. The certified copy of work specification of the project.
11. The certified copy of documents submitted by tender participant for Technical Bid.
12. The certified copy of Tender participant who have qualified the Technical Bid in the Tender Process of this projects as per District Based Entrepreneur and professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
13. Name of firm who won the Tender work with respect to the subject mentioned above.



14. Name of Officer & their Designation at the time of monitoring the work.
15. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
16. Furnish the certified copy of Contractor Enlistment Order (Civil/Composite Category as per the nature of work), of tender participant and winning Firm.
17. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
18. Furnish the certified Integrity Pact submitted by the tender participant.
19. Furnish the certified Affidavit copy (The Affidavit should mention the names of the incomplete ongoing commitments) Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have more than 2 (Two) incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. as per rule SPWD/W-66/2012 Dtd. 01-08-2018 and Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules no. 4(ii(e)), 2015 & 2020).
20. Furnish the certified copy of Work Experience documents submitted by the tender participant and winning firm, (i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer,) in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
21. Furnish the certified reason and method of adopt in TURNKEY/ EPC Basis of the project is executed by these Basis.
22. The certified copy of Acceptance letter for Tender work by the Executing Agency to the tender winning firm.
23. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
24. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
25. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work.
26. Furnish the certified Photograph (Glossy Paper) after completion of each work items.
27. Furnish the Geo Coordinate information before the start of projects and after the start of the project mentioned above.
28. Furnish the certified Payment Details (Cheque details, voucher, PFMS etc. (Which ever method is used of payments)) of the project till date.
29. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
30. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
31. Furnish the certified Affidavit to invest cash upto (25% of tender value) submitted by the tender participant.
32. Furnish the certified copy of Utilization Certificate for the amount exempted in the NIT from the Total Sanctioned amount.



**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellant, Shri Tamchi Gungte had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (PWD), Cntral Zone – A, Govt. of A.P Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 19-06-2025.

Records further disclose that the FAA had conducted the hearing on 06.08.2025 wherein the appellant Shri Tamchi Gungte was present but the respondent PIO, was absent. The FAA, after hearing the appellant, passed the following direction to the PIO vide order dt.12.08.2025:

*"In accordance with the hearing notice dated 30/07/2025. The appellant is present but the Respondent PIO is absent for the hearing on RTI 1<sup>st</sup> appeal received on 19/06/2025 regarding C/o Development of Wayside Amenities at Tago Putu, Yazali, Lower Subansiri District, Arunachal Pradesh during Financial Year 2017-18 under NEC Project. Particulars of sought information are sanction order copy, Technical Sanction, Utilization Certificate, Notice Inviting Tender & Progress Report etc.*

*Heard the case, from the appellant, it is found that the information sought was not furnished. The respondent was contacted over phone and informed that the documents are ready at division office which shall be furnished to appellant. Accordingly the appellant also agreed to take the documents from PIO cum EE Yazali Division.*

*Hence the case is disposed of with liberty to the appellant to prefer second appeal to the SIC as per section 19(3) of the RTI act.*

The appellant, however, preferred his 2<sup>nd</sup> appeal before this Commission vide his Memo of Appeal dt. 25.08.2025 on the ground that the PIO had furnished improper and irrelevant information.

This appeal is, thus, listed today on 12.12.2025 wherein the appellant, Shri Tamchi Gungte and the representative of the PIO, Shri Bengia Chito are present in person.

Heard the parties.

The appellant submitted that the PIO had earlier furnished some of the requested information/documents but he was not satisfied with the same. The representative of the PIO, on the other hand, submitted that the implementation of the project in question was initiated by the department of Tourism and therefore, the records were not available with the o/o the PIO (PWD, Yazali Division) but now that the records have been handed over to the o/o the PIO, the requested information /replies are being furnished to the appellant. The representative of the PIO, accordingly, brought in the documents, being forwarded vide letter dt.11.12.2025, a copy whereof is also endorsed to this Commission.

The documents so brought in by the PIO's representative are handed over to the appellant who shall go through the same and report his satisfaction or otherwise therewith to this Commission within 1(one)week from today for further consideration of the appeal.
