ORDER

The 1st hearing held on **21st April, 2026** related to the **APIC-No-907/A//2025**. The Appellant Miss Bengia Mama, present during the hearing, the PIO-O/O-Arunachal Pradesh Building & other Construction Works Welfare Board (APB&OCWWB, present during the hearing.

Heard the Appellant;

The Appellant stated before the Commission, that no information have been provide to her by the PIO till today.

Heard the PIO,

The PIO stated before the Commission that the certain information are not available with his office and therefore, the information are not available with is office and not maintained at certain subordinate office, I have written to those officer to provide to him the information. So that he can pass on provide the information to the Appellant.

As the Appellant has file many application before the same office it is that not easy to provide to her information in one go that for the reason that she has asked information spanning to 5(Five) years, this being one of the main reason of delayed in provided the information. However, the court order that the information will be provide to the Appellant within 45 days time from today.

After hearing both the parties the Commission hereby orders;

- i) The PIO to provide the complete information to the Appellant within 45 days from today **failing necessary action as provided by the RTI Act 2005 shall be initiated against the PIO.**
- ii) The Appellant to collect the information from the PIO and to be present in the next date of hearing to ascertain the receipt of information from the PIO, failing to attend the hearing this Commission will heard and determined ex-parte.

After hearing both the parties the Commission hereby orders;

Notice need not be issued both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 7th July' 2026' at 2:30 PM.
