Information sought:

The appellant filed an RTI application dated 08.10.2025 seeking information regarding C/o MIC work at Higio village, Gangte circle under WRD Palin Division.

Details of information required:

- Furnish utilization certificate copies
- Furnish Money Receipts with cheque counterfoils of the contractors' copies.
- Furnish Complete Reports with details of first and final bills copies.
- Furnish Details of Photograph before, during and after copies.
- Furnish Work progress report copies.
- Furnish Site inspection report copies.
- Furnish Geo tech report copies.
- Furnish the name of technical officer like JE etc.

Details of information required: - As state in Serial No.3(i to v)

Period for which information asked for: period between 2022-23.

The following were present.

Appellant : Present. He states that he has not received any information document from the PIO in spite of the order passed by the FAA for furnishing the information.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the appellant, observes that the FAA cum Chief Engineer (W/Z) WRD, Itanagar has heard and disposed of the appeal case on 09.02.2026 with a direction to the PIO to furnish all the information sought to the appellant within 30 days from the date of issue of their order. The PIO is absent in today's hearing without any intimation of the reason thereof, which is a violation of statutory duty of a public authority under the provisions of RTI Act, 2005.

Ex parte decision taken in the absence of PIO. The PIO is directed to furnish information sought to the appellant within 2 weeks from the date of issue this order under intimation to this commission. The appellant shall serve a copy of this order to the office of the PIO, obtain acknowledgement and submit a copy of it to this commission. The PIO shall personally attend the next hearing or through his authorised representative.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
