Shri Pisa Tapam -V/S- PIO-Cum-EE, RWD, Laayang-Yangte, Sangram K/Kumey District

ORDER

The 7th hearing held on **14th day of July' 2026'** related to the **APIC No-242//2024**. The Appellant Shri Pisa Tapam is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), RWD, Laayang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh is represented by Shri Yangbiu Loka, Assistant Engineer, Laayang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has not provided him information that he has applied under Serial No. 16 of his Form-A despite the PIO assuring to provide the information before the next hearing on 28.04.2026, while the next hearing is today, and therefore, the PIO was under liability to furnish the information to him, before today's hearing.

For the information not available with the PIO, but available with the Executive Engineer, RWD, Koloriang Division, the PIO had assured to transfer the Form-A to The PIO-cum-Executive Engineer, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh for which a copy of the letter written to the Executive Engineer, Koloriang Division had to be made available to him also.

Heard the representative of the PIO;

The representative of the PIO stated that the PIO could not attend today's hearing because of medical reason, and therefore, requested him to appear before the court hearing on his behalf, further the representative of the PIO prayed before the court to give a little more time to the office of the PIO to furnish the information(s) to the Appellant.

After hearing both the parties the Commission hereby observes;

- i) In the last hearing held on 28.04.2026 the PIO had assured the Commission that he will transfer the Form-A of the Appellant to the PIO-cum-Executive Engineer, RWD, Koloriang Division, wherein, out of 17 numbers of projects information(s) sought by the Appellant have been executed by the Executive Engineer, RWD, Koloriang Division, in that line the PIO-cum-Executive Engineer, RWD, Laayang Yangte has transferred the Form-A of the Appellant to the Executive Engineer, RWD, Koloriang Division on 22.05.2026, a copy of which is made available to the Commission.
- ii) The PIO in the instant appeal was to provide the information related to Serial No. 16 of the Form-A of the Appellant i.e information about Construction of Road from Laayang to Majuriang (35 KM) stage-II, as he has assured the same before the court of this Commission at the 6th hearing held on 28.04.2026.
- iii) Instead of furnishing of information to the Appellant, the representative of the PIO still prays for giving time of one month to furnish the information to The Appellant.

- iii) Instead of furnishing of information to the Appellant, the representative of the PIO still prays for giving time of one month to furnish the information to The Appellant.

Under the above observation the Commission hereby order as given bellow;

- a) The Executive Engineer, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh to provide the information as sought by the Appellant in his Form-A which has been transferred from the Executive Engineer, RWD, Laayang Yangte, Kurung Kumey District, Govt. of Arunachal Pradesh.
- b) Send Summons to the PIO-cum-Executive Engineer, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- c) The information relating to Serial No. 16 of the Form-A of the Appellant be provided to the Appellant within 20 days from today, failing which the Commission will be compelled to penalize the PIO-cum-Executive Engineer, RWD, Laayang Yangte by the Commission for disobeying the order of this Commission.
- d) Notice need not be sent to the PIO-cum-Executive Engineer, RWD, Laayang Yangte and the Appellant as both are present in the court today..

The Commission hereby orders;

The next date of hearing be fixed on 24th day of September' 2026 at 10:30 AM (Morning).
