### ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Konsa.

2). **The 3<sup>rd</sup> hearing was held on 3<sup>rd</sup> February' 2026.** Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, appeared before the Court through video conferencing. The Appellant Shri Wangnon Wangnow appeared in person before the Court.

3). The PIO submitted that he had not received the summon notice for the hearing so he could not attend the last hearing. The PIO also informed that he had tried to contact the Appellant through phone but the Appellant did not receive the call, now therefore the complete information could not be furnished.

4). The Appellant refuted the PIO's claim and informed that he had never received any call from the PIO. The Appellant showed proof that he had sent message through whatsapp to the PIO seeking information, but the message was never seen by the PIO. The Appellant also informed that some of the information and the DPR provided by the PIO were not as per the information sought by him in the Form-A Dated 05/02/2025.

5). The Commission directed the PIO to give his contact no (9366229218) to the Appellant. The PIO was also directed to furnish all the available information to the Appellant on 10<sup>th</sup> February'2026 and in case the information were not available the PIO must give justifiable reasons in writing.

6). The Commission directed, the Appellant to contact the PIO on 10<sup>th</sup> February'2026, visit the office, sit together, sort out issues and get complete information. The Appellant was directed to intimate the Commission in writing, his satisfaction or dissatisfaction after, receipt of the information.

6). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given, the case would be disposed of.
