**ORDER**

The 1<sup>st</sup> hearing held on 16<sup>th</sup> Sept'2025, related to the APIC No- 461/A/2025. The Appellant Shri Yamra Ela, present during the hearing and the representative of the PIO Shri Gollo Nera I/c Assistant Public Information Officer( APIO), present during the hearing.

**Heard both the parties.**

The representative of the PIO stated before the Commission that he has been furnished with some of the information(s) but still some more information(s) are to be provided to him.

The representative of the PIO stated that the PIO has written a letter to all the concern **Range Forest Officer (RFO)** to provide the information(s) to him. So that he can further furnish the information(s) to the Appellant. The letter was written on 6<sup>th</sup> June 2025 but the **Range Forest Officer (RFO)**, have not yet submitted back the information(s) to the PIO. In the meantime unfortunately the **Range Forest Officer (RFO) Bomdila** , died due to prolong illness.

**The Range Forest Officer (RFO) Khupi** Forest Division was transferred in the month of 30<sup>th</sup> April'2025 and this is the reason why complete information(s) have not been provided to the PIO, so that it can be furnished to the Appellant.

However the representative of the PIO stated before the Court that the remaining information(s) pertaining to the Sl. No. 3,4 & 9 of the Form 'A' of the application will be provided to the Appellant within 15<sup>th</sup> days from today that is on or before the 1<sup>st</sup> Oct'2025.

**After hearing both the parties the Commission herby orders;**

- i) The PIO to provide remaining information(s) to the Appellant on or before 1<sup>st</sup> October 2025.
- ii) The Appellant to collect the information(s) form the office on or before the next date of hearing and convey to the APIC if he has received full information or not as applied.
- iii) To ascertain the receipt of the complete information(s) by the Appellant, the PIO to be present the next date of hearing without fail.
- iv) The Appellant to be present in the next date of hearing without fail.

**The Commission order;**

**The next date of hearing fixed on 13th Jan'2026 at 1.30 PM (Afternoon)**

The next date of hearing has been intimated to both the parties, so no formal notice required to be issued.
