- 2). The 2nd hearing was held on 2nd December' 2025 (Tuesday) at 1100 hrs. Shri Kini Zirdo, the PIO-Cum-EE(PWD), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh was absent. The Appellant Shri Tamchi Gungte was also absent.

The PIO submitted a letter Vide No. RD/CT-50/2025-26/2318 Dated Roing, the 28th November 2025 addressed to the Commission with a request for deferment of the 2nd hearing, since he was a engaged for Panchayat Election duty and by the State Govt of Arunachal Pradesh. Further, the PIO stated that the APIC-89/2025 case was disposed of under S.Tsering Bappu the Hon'ble State Information Commissioner on same subject since all information had been furnished to the Appellant.
- 4). The Appellant was absent for today's court hearing and it is assumed that he is satisfied with the information so furnished by the PIO.
