ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the (APB&OCWWB), Itanagar as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 15.09.2025.

Furnish the copy of the merit Tax Invoice along with GST No. of the M/S K.T Traders, G-Extension, Kipa Commercial Centre, Nlg. Submitted by the power of Attomy Holder or proprietor in connection to be the Deed of Agreement/MOU between Secretary APB&OCWWB, Itanagar and M/S K.T traders dt. 26.03.2021 pertaining to the supply of 23402 No. of Water Filter in the year 2021.

Brief facts and decision thereon:

Records reveal that the Appellant, Ms. Bengia Mama, vide her application dt. 15/09/25, had asked for the above mentioned information from the PIO, o/o the

Arunachal Pradesh Building & Other Construction Workers welfare Board (APB&OCWWB), Itanagar. A.P. but could not obtain the same which prompted her to approach the Secretary cum First Appellate Authority, Arunachal Pradesh Building & Other Construction Workers Board (APB & OCWWB), Itanagar under section 19 (1) of the RTI Act. 2005.

But the appellant yet again failed to get the sought for information and as such she filed her 2nd Appeal before this Commission under section 19 (3) of the RTI Act vide her Memo of appeal dt. 16.12.2025.

This appeal has, accordingly, been registered in this Commission as APIC 910/2025 and listed for hearing today on 27.05.2026 wherein the PIO, Shri Konu Pordung appeared through VC while the appellant is present in person.

Heard the parties.

The appellant, reiterating her demand for the requested information/documents, pleaded for an appropriate direction to the PIO to furnish the same. The PIO, however, replied that the audit of the Board's account by the PAG, Itanagar is now going on and as such it will not be possible to furnish the requested documents which are currently under the custody of the Audit party and that the requested documents shall be furnished to the appellant as soon as the audit work of the Board is completed.

Under the circumstances, this Commission directs the PIO to provide the requested information as soon as the audit work of the Board is over but not later than 45 days from today.
