### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bengia Papo for non-furnishing of below mentioned information by the PIO, o/o the (DDSE), Koloriang, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 25.06.2025:

**A) Particular of information:** To furnish all the relevant information against the appointment of MTS/ PRT/ TGT/ UDC/ LDC under Education Department.

**B) Details of information required:**

1. Furnish the name of all the MTS/PRT/TGT/UDC/LDC staff list with appointment order copy/Joining Report copy/Education Qualification like matric passed/Twelve passed/ Degree passed/B. ED/ DIET passed Certificate/STC/PRC advertisement published in local daily newspaper with mentioned the name of newspaper/date.
2. Furnish the name of board committee member for selection of candidates with their designation.
3. Furnish the candidate answer sheets/OMR-with question paper sheet details.
4. Furnish the recommendation note sheet copy of Minister/concern MLA for appointment.
5. Furnish the details name/ address/mobile number/ email address of the candidate who have attended the examination.
6. Furnish the total mark obtain by the candidate along with their answer sheets.
7. Furnish the total number of candidates who have appeared for the exam along with their details.
8. Furnish the name & contact number of the examiner.
9. Furnish the requirement qualification to induct into PGT/ TGT/ PRT/ MTS/ UDC/ LDC into the School Department.

**C) Period from which information asked for: 2019-2025.**

### **Brief facts and decision**

The brief facts of the Appeal are that the Appellant, Shri Bengia Papo having been denied the aforementioned information by the PIO, had approached the First Appellate Authority, the Directorate of School Education Govt. of A.P, Itanagar.

However, the Appellant, apperantly, having failed yet again to obtain the requested information, filed his Second Appeal before this Commission under section- 19(3) of the RTI Act, vide his Memo of Appeal 13.10.2025.

This Appeal was, hence, listed for hearing on 13.02.2026 and summons were issued to the parties accordingly. However, the Appellant, Shri Bengia Papo informed this Commission, vide his letter dated 02.02.2026, that he has received the requested information from the PIO i.e the Deputy Director of School Education Koloriang and requested to disposed of the Appeal.

In the premises as above, this Appeal does not warrant any adjudication in this Commission and resultantly, the hearing fixed on 13.02.2026 stands cancelled.
