**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC- 587/2025.**

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bachunum Yun for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Hawai Division, Anjaw District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.01.25.

- q. Technical Bids
- r. Financial Bids.
- h. Certified copy of Board Members of the Tender Processing.
- i. Certified copy of Bank Solvency Certificate of the Firm who did the work/scheme.
- j. Certified copy of affidavit of having not more than 2 (two) work in hand under the State Govt.by the firm.
- k. Certified copy of GST registration certificate, Income Tax clearance certificate, latest Audit report of last 3 (three) years dully certified/ Audited by the Chartered Accountant of the firm who did the work/scheme.
- l. Certified copy of Measurement book of the said work.
- m. Certified copy of First and Final bill of the said work.
- n. Certified copy of Cashbook Statement with page numbers or give hand receipt with Payee name of the said work.
- o. Certified copy of details of payment done through cheque/PFMS as mention in the First and Final bill.
- p. Certified copy of photograph with GPS Coordinates/Geo-tag of the said work, before starting, ongoing and after completion of the said work/scheme.
- q. Certified copy of design and drawing of the said work/scheme.
- r. Certified copy of utilization and completion certificate of the said work/scheme.
- s. Certified copy of name of EE/AE/JE who executed the said work/scheme/project.
- t. Certified copy of status of the work, if not completed give the specific reasons why not completed.
- u. Certified copy of duration of completion of the said work/project as per agreement and extension duration of the said work.

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellant, Shri Bachunum Yun had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (RWD), E/Z, Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 24.03.2025.

The record further reveals that the APIO, o/o the CE (PMGSY), RWD, Itanagar, vide its letter dated 6<sup>th</sup> May, 2025 advice the EE, RWD, Hawai, Anjaw District, A.P. to furnish the required information to the appellant at the earliest but there is no further record of any correspondence. As such the appellant filed his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.07.07.2025.

The appeal is, accordingly, registered and listed for hearing today on 17.09.2025 wherein the appellant, Shri Bachunum Yun is present in person while the PIO is represented by his APIO, Er. Shri Jaki Tulang, A.E.

**Hearing and decision :**

The appellant reiterating his demand for the information, pleaded for an appropriate direction to the PIO to furnish the information. The APIO, on the other hand, submitted that the requested documents/information are kept ready to be furnished to the appellant. He also stated that the appellant was already advised through registered letter to collect the documents.

This Commission, in view of the submission of the APIO, directs the appellant to collect the requested documents from the o/o the PIO within 1(one) week from today and report his satisfaction or otherwise theewith within one week thereafter for further consideration of this appeal. Further, the PIO is directed to allow/facilitate the inspection of the work as requested by the appellant in his RTI application which may be carried out on mutually convenient date.
