# **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PHE & WS), Koloriang Division, Koloriang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.06.2025:

A)Particular of Information: BE- 2024-25

# B) Name of Scheme:

- 1. Reconstruction of flood damage water supply at Rilong village under Koloriang PHE & WS Division.
- 2. Restoration and reconstruction of flood damaged water supply and installation at Sibi village under Koloriang PHE & WS Division.
- 3. Relaying of pipe and re-construction of flood damage over head tank of Govt. Higher Secondary School, Koloriang.
- 4. Restoration of flood water supply installation at Parsi Parlo section under Koloriang PHE & WS Division
- 5. Relaying of pipes at slides affected stretch of water supply projects at Damin Sub-Division under Koloriang PHE & WS Division
- 6. Relaying of flood damage water supply installation at Sarli section under Koloriang PHE & WS Division
- 7. Restoration and reconstruction intake work of flood damaged water supply installation at Paniasang section under Koloriang PHE & WS Division
- 8. Relaying of flood damage water supply installation at Paniasang Circle under Koloriang PHE & WS Division
- Restoration of flood damage water supply installation at Koloriang Sub-Division section under Koloriang PHE & WS Division

# 10. Furnish the details Information:

- 1. Furnish the certificate of all the completed schemes
- 2. Furnish the Utilization Certificate of all the completed scheme.
- 3. Furnish the purchase invoice copy of pipe, fitting items etc.
- 4. Furnish work completion certificate of each work site with geo-tag
- 5. Furnish the geo-tag copy from starting point to ending point of each work site.
- 6. Furnish the detail of GST /royalty and other govt. revenues deposit in government account of each scheme.
- 7. Furnish the site inspection report of each scheme
- 8. Furnish name of engineers deployed for inspection of each scheme.
- 9. All the furnish documents must in the True Certified copies by concerned PIO.

# Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Pisa Tapam had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (PHE & WS), Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 29.07.2025. But having failed to obtain any response from the PIO or the FAA the appellant filed his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.04.09.2025.

# Hearing and decision:

The appeal is, accordingly, heard today on 21.11.2025 wherein the APIO, Er. Shri Bamang Marik, AE appeared through the VC but the appellant, Shri Pisa Tapam was absent without any intimation.

Heard the APIO, who submitted that although both he and his PIO, the EE had joined the present place of posting only last month, the information/documents requested by the appellant have been collated and are ready for furnishing to the appellant but due to unclear address of the appellant, the information could not be furnished to him. He, however, assured that the documents/information comprising of some 40-45 pages will be despatched to the appellant through the speed post.

In view of the assurance given by the APIO as above, the appellant is directed to visit information /documents from the Post Office concerned within 2(two) weeks from the date of receipt of this order and within 1(one) week thereafter intimate this Commission of the receipt of the same failing which this appeal shall stand closed without any further notice presuming that he has received the information and is satisfied therewith.
