An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC-424/2025.

APPELLANT : Ms. Bengia Mama, Dariya Hill colony, Itanagar.

RESPONDENT : The PIO, o/o the Executive Engineer (PWD), Aalo Division
West Siang District.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Aalo Division, West Siang District (A.P) as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 05.01.2025.

A) Particular of information: Juvenil Home at Kombo Jirdin Village, West Siang District Arunachal.

B) Details of information required:

1. Furnish a copy of Sanction Order.
2. Furnish a copy of the Details Project Report (DPR).
3. Furnish Work order
4. Furnish TS copy
5. Furnish Geo Tagging details in colouring photos
6. Furnish detail copies of Material Procurement of Challans
7. Furnish Photograph of project before during and after the completion of the project in coloring photo.
8. Furnish Payment Cheque leaf/ PFMS/DBT transaction receipt copy
9. Furnish Notice Inviting Tender (NIT) details with NEWS paper cutting. The name of the newspaper and date of the publication must be clear and visible.
10. Furnish a copy of the Name of bidder or winner Firm with detail supporting technical bid documents of the winner Firm (Bidder).
11. Furnish a copy of the Name of all the tender participants along with detail technical documents submitted by the participants.
12. Furnish a copy of the Name of the Officers involved in the said project.
13. Furnish a copy of the details on the grounds for rejection of the technical bids of all bidders who were disqualified in the evaluation process. This should include specific deficiencies or no-compliances with the tender requirements.
14. Furnish copy of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals.
15. Furnish a copy of MIS Report.
16. Furnish a copy of Completion Certificate.
17. Furnish a copy of Utilization Certificate.
18. Furnish a copy of the Land Agreement Letter (in Affidavit form) in between land owner (Land donor) and the concerned department.

19. Furnish a copy of the details of the total hectares or square meter of the donated land for the same.
 20. Furnish a copy of the MOU or Agreement signed between Department and Proprietor/contractor.
 21. Furnish a copy of Quarter Project Report (QPR).
 22. Furnish a copy of CA BOOK (Contract Agreement Book).
 23. Furnish a copy of GST return 3B filed of all the Suppliers/ contractors before releasing payment.
 24. Furnish a copy of MB (Measurement Book) details.
 25. Furnish a copy of the LPC/Land Allotment details of the said donated land.
 26. Furnish a copy of the KYC viz: Aadhar card and Pan card of the proprietor of the winner Firm.
 27. Furnish all the documents viz: Acknowledgment Letter, Challan letter and other related documents etc. in the above mentioned address through "Register Post".
 28. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of receipt.
- C) Period for which information is sought for: 2023 to 2024.

Brief facts emerging from the appeal:

The records in the appeal reveal that the appellant, Ms Bengia Mama, vide her RTI application dt. 05.01.2026, had requested the PIO for the aforementioned information but failed to obtain the same which prompted her to file her 1st appeal before the Chief Engineer, Central Zone B, PWD, Pasighat, the First Appellate Authority (FAA) under section 19(1) of the RTI Act via his Memo of Appeal dt. 05.03.2026.

The records in the appeal, however, do not indicate as to whether the FAA had conducted the hearing and passed any order thereon but the appellant, vide her letter dt. 18.05.2026 requested the FAA for the copy of judgement on the hearing conducted on 07.05.2026. The appellant, however, apparently, failed to get response from the o/o the FAA and the PIO prompting her to file her 2nd appeal before this Commission under section 19(3) of the RTI Act, 2005 vide appeal Memo dt. 10.06.2026 on the ground of non-furnishing of requested information.

Hearing and decision:

This appeal is, accordingly, listed today, on 02.09.2026 wherein the appellant, Ms Bengia Mama is present in person while the PIO, Er. Shri Kitum Siram attended through VC.

Heard the parties.

The appellant submitted that the PIO has furnished her replies/information to some of the queries (Queries No.4 and 8) but did not furnish replies to the remaining queries. The PIO on the other hand contended that the replies to the remaining queries were also dispatched to the appellant through post office but he could not produce any documentary evidence of the receipt of the documents by the appellant. He, however, assured that the documents/information to those left out queries shall be furnished to her which she has to collect from his office. The appellant agreed to depute someone to the o/o the PIO on 04.08.2026 to collect the documents.

In the premises as above, the PIO is directed to furnish the requested documents /information excepting those which are exempted from disclosure under section 8 of the RTI Act, such as L.P.C (Sl.No.25), the KYC viz: Aadhar card and Pan card of the proprietor of the winner Firm (Sl.No.26) which are personal information of third parties.

The appellant is directed to intimate to this Commission the receipt of the documents/information within 1(one) from the date of receipt of the same from the PIO for further consideration of the appeal.
