



## **ARUNACHAL PRADESH INFORMATION COMMISSION**

### **ITANAGAR.**

**An Appeal Case U/S 19(3) of RTI Act, 2005  
Case No. APIC-278/2025.**

**APPELLANT** : Shri Chow Chali Simit & Shri Ratan Chetia.

**RESPONDENT** : The PIO, o/o the District Project Coordinator-Cum-PIO, ISSE, Samagra Shiksha District Society Namsai District (A.P)

### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Chali Simit & Shri Ratan Chetia for non-furnishing of below mentioned information by the PIO o/o the District Project Coordinator-Cum-PIO, ISSE, Samagra Shiksha District Society, Namsai, District : Namsai Govt. of Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 07.12.2024:

**A) Particular of information required:** Details of teaching and non teaching staffs under Education Department in various Schools and Offices in Namsai District.

**B) Details of information required:**

Sl. No	Information required	Remark
01	Furnish the list of working staffs with their designation in the office of DPC, DDSE, BRC Lekang, BRC Chongkham in the District of Namsai	
02.	Furnish the certified true copies of appointment letters of all the working staffs as mentioned above, Sl 3 (01)	Furnish from the competent authority
03.	Furnish the CT copies NIT published for all the posts of the working staffs as mentioned above in Sl. No. 3 (01)	Furnish newspaper cuttings, advertisement etc.
04.	Furnish the sanctioned strength of working staffs and present strength in the office of DPC, DDSE, BRC Lekang, BRC Chongkham in the District of Namsai.	Furnish from the competent authority.
05.	Furnish the list of all the newly appointees of teaching staffs (if any) during 2023 to till date in Middle Schools, Secondary Schools and Higher Secondary Schools in Lekang Circle and Namsai circle with their all eligibility qualification.	
06.	Was the Selection process of the appointees mentioned above in Sl. 3 (02), (05) in compliance with government rules and regulations.	If yes, provide relevant guidelines / notifications.
07.	Whether the selection process conducted under recorded form?	If yes, provide the relevant videos in S Drive (Pendrive)

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellants, Shri Chow Chali Simit & Shri Ratan Chetia had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the State Project Director, Integrated Scheme for School Education, Samagra Shiksha Society, Arunachal Pradesh, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide their Memo of Appeal dt. 22-01-2025. However, the appellants having failed yet again to obtain the information preferred second appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of appeal dated 17.03.2025.

**Hearing and decision:**

This appeal was heard on 25<sup>th</sup> July, 2025, wherein one of the appellants, namely, Shri Ratan Chetia and the PIO, Shri Jumbom Gamlin, District Project Co-ordinator (DPC), ISSE were present through VC.

This Commission, upon hearing the parties and on perusal of the points on which the appellants had sought the information / documents, found that the requested information were not covered by any the exemption provisions. This Commission, therefore, directed the PIO to provide the information, as assured by him, to the appellant within one week from the date of receipt of the order and the appellant was also directed to intimate this Commission of the receipt of the documents and his satisfaction therewith within one week from the date of receipt of the documents for further consideration of the appeal.

The appellant, Shri Ratan Chetia vide letter dated 3<sup>rd</sup> August, 2025 complained that he has received the information from the PIO on 01.08.2025 but the following information have not been provided by the PIO:

(i)	Sl. No. 3 (01)	Separate list of Working staffs (regular, casual, contractual, contingency).
(ii)	Sl. No. 3 (02)	Copy of advertisement not provided.
(iii)	Sl. No. 3 (04)	Sanctioned strength and present strength of staff.

This appeal was, therefore, listed today on 12.09.202 again with the direction to the PIO to provide the requested information to the appellants in complete and satisfactory form and report compliance thereof on or before 12.09.2025.

This appeal is, thus, heard today wherein the appellant again appeared through the VC while the PIO, Shri Jumbom Gamlin, DPC is present in person with the copies of left out documents which were furnished to the appellant vide letter dt. 04.09.2025.

This Commission perused the documents and found that the same have been correctly and satisfactorily furnished to the appellants as per their RTI application. However, the appellant, Shri Ratan expressed some reservations about the details of sanction strength and the present strength shown in the table which the PIO assured to explain and clarify to the appellant later in his office to which the appellant has agreed. This Commission, therefore, directs the appellant to visit the o/o the PIO and get his doubts/reservation cleared at his convenience.

This appeal is disposed of and closed in above terms.
