An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-288/2026

Shri Dohu Penji -V/S- PIO-Cum-EE, PWD, Yazali, Keyi-Panyor District

ORDER

The 1st hearing held on **14th day of July' 2026'** related to the **APIC No-288/A/2026**.

The Appellant Shri Dohu Penji is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PWD, Yazali, Keyi Panyor District, Govt. of Arunachal Pradesh is represented by Shri Toko Dopum, Junior Engineer, Yachuli Sub-Division, PWD, Govt. of Arunachal Pradesh during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that no information(s) have been furnished to him till now by the PIO.

Heard the representative of the PIO;

The representative of the PIO stated that the Appellant had applied for information by not properly mentioning the name of the work and so the office of the PIO rejected the Form-A of the Appellant and sent a letter to the Appellant on 24.01.2026 citing the reason for which the Form-A was rejected.

After that the Appellant corrected the name of the project and applied for the information(s) but unfortunately a Central Bureau of Investigation (CBI) inquiry and investigation was going on with the works related to the office of the PIO, and therefore, the whole office staffs were busy in procuring and providing the information(s) to the CBI, the information(s) in the last 10 (ten) years of work that was executed by the office of the PIO but, now after the files were given back to the PIO from the CBI the information(s) as applied by the Appellant and as available with office of the PIO have been compiled and brought to the court today to be handed over to the Appellant.

After hearing both the parties the Commission hereby order as follows;

- 1) The Appellant to receive the information from the PIO and go through the information(s) that the representative of the PIO has provided to him in the court of the Commission.
- 2) The PIO to be present in the next date of hearing without fail to ascertain from the Appellant the information provided by PIO's office is complete as applied. In the event of the failure to attend the next hearing the PIO shall be initiated against as per the provisions of RTI, Act, 2005.

- 3) The Appellant to go through the information(s) as provided by the PIO and to let the Commission know whether the complete information(s) have been provided to him or not, in the next hearing the Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the PIO has provided him the complete information, and therefore, this appeal will be heard and determined ex-parte, by way of disposing this appeal.
- 4) Notice for the next date of hearing need not be sent to both the parties as both parties present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 24th day of September' 2026 at 10:30 AM (Morning).
