ORDER

The 1st hearing held on 16th Sept'2025, related to the APIC No- 597/A/2025. The Appellant **Shri Odi Menjo**, present during the hearing and the PIO -cum- EE (PHE & WS) Roing Division also present during the hearing.

Heard both the parties.

The PIO stated that he was not the PIO while the Appellants had submitted the application but upon the present PIO taking charge as EE (PHE & WS) Roing Division, he had attended the hearing at the First Appellate Authority (FAA) on 19/6/2025, but the Appellant was absent during the hearing.

The information(s) are ready to be furnished to the Appellant and had the Appellant been present on the day of the hearing at the First Appellate Authority (FAA) the information(s) would have been furnished to the Appellant by that time itself.

However, the PIO has brought all the information(s) to be furnished to the Appellant and therefore, asked the permission to the Court to hand over the information(s) to the Appellants to which the Court granted.

The Appellant has requested the Court of the APIC to give him some time to go through the information(s) which he has received today, to which the Court has agreed and therefore.

After hearing both parties the Commission hereby orders;

- i) The Appellants to go through the copies of the information(s) that have been handed over to them by the PIO and see that they are in receipt of the complete information or not.
- ii) To ascertain the receipt of the complete information(s) the Commission hereby fix another date of hearing.
- iii) The Appellant to be present on the next date of hearing without fail.
- iv) The PIO-cum EE (PHE&WS) Roing Division to be present on the next date of hearing without fail.
- v) Notice need not be sent to both the parties as both are present in the Court today.

The Commission ordered;

The next date of hearing has been fixed on **13th Jan'2026 at 01.30 PM (Afternoon)**

The next date of hearing has been intimated to both the parties, so no formal notice required to be issued.
