This should include specific deficiencies or no-compliances with the tender requirements. 14. Furnish copies of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals. 15. Furnish Completion Certificate. 16. Furnish Utilization Certificate. 17. Furnish the monthly physical monitoring report from Directorate Office, SJETA Itanagar. 18. Furnish colouring photos of monitoring team from Nodal Officer, Director Office, SJETA, Itanagar during physical inspection in the project site. 19. Furnish the Report of Technical Scrutiny of Estimate for the works by competent authority is being obtained by the State Govt.

The following were present.
