ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Matheim Linggi, Mayu-II, PO/PS Roing, Lower Dibang Valley District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- DLRSO, Roing, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/10/2025 regarding Land Acquisition for construction of Right Bank Road from ADC Morh to Mithun Gate at New Apali and additional facility area / stretch 1st to 6th measuring 68.88 hectares.
- 2). The 1st hearing was held on 31st March' 2026. Shri Hibu Doley, PIO -cum- DLRSO, Roing, Lower Dibang Valley District, Arunachal Pradesh, had appeared before the Commission through online video conferencing. The Appellant Shri Matheim Linggi, was present in person.
- 3). The Appellant had informed the Commission that the PIO had furnished incomplete information on 26th March'2026; information sought at Sl.no. 'd' of the Forma A dated 27/10/2025 had not been furnished.
- 4). The PIO had submitted that while all the information were furnished, additional information could be furnished to the Appellant on his visit to the Office.
- 5). The Commission had asked the Appellant to visit the Office of the PIO and get complete information. The Commission also had directed the PIO to furnish complete information to the Appellant within two weeks from the date of issue of the order dated 31st March'2026. The Appellant was also asked to intimate his satisfaction or dissatisfaction after receipt of information to the Commission.

6). The Appellant vide letter dated 17 / 04/2026 informed the Commission that the PIO had not furnished information, specifically:-

- i. Assessment Sheet of 17.62 Ha and
- ii. Decision of Public hearing pertaining to 17.62 Ha by ADC Dambuk.

Further, the Appellant appealed for compensation to the amount of Rs. 20, 000/- under section 19(8)(b) of the RTI Act, 2005.

7). The Commission, in view of appeal from the Appellant directs the PIO to furnish above information if available in record. In case, information are not available the PIO is directed to give justifiable reasons in writing. The Appellant may submit bills and the details against the claims for compensation. The Commission, decided to fix a date of hearing to facilitate resolve the case.

8). **The next date of hearing of fixed on 26th May'2026 (Tuesday) at 1100hrs**

9).Therefore, Shri Hibu Doley, PIO -cum- DLRSO, Roing, Lower Dibang Valley District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

10). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
