ORDER

The 3rd hearing held on **10th February' 2026** related to the **APIC No-96/2024**. The Appellant shri Tap Tapum Hiyang is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, RWD, Jamin Division, Kra-Daadi District, Govt. of Arunachal Pradesh is represented by Shri Byabang Takar, Junior Engineer (JE)-cum-PIO, Jamin Division during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that despite order from the court of the Arunachal Pradesh Information Commission on 09.04.2024 as well as 14.10.2025 to provide him full information(s) the PIO has not bothered to furnish the information(s) to the Appellant, till now.

Heard the APIO;

The APIO requested the Commission for giving some more time to provide the information as available with the office of the PIO before the next date of hearing.

After hearing both the parties, the Commission hereby order;

- i) Considering the request of the APIO for some more time to furnish the information, the Commission hereby considers one last chance to the PIO to provide the information as applied by the Appellant.
- ii) After giving ample time to provide the information(s) to the Appellant, the failure of the PIO to provide the information(s) to the Appellant before the next date of hearing will attract action against the PIO as per the provisions of RTI, Act, 2005.
- iii) The PIO to be present in the next date of hearing without fail, failing which disciplinary action against him will be initiated as per the provisions of RTI, Act, 2005.
- iv) The Appellant to be present in the next date of hearing without fail to intimate the Commission, the receipt or non-receipt of the information(s) from the PIO.

v) The absence of the Appellant in the next date of hearing will lead to the hearing and determination of this appeal ex-parte.

The next date of hearing be fixed on 5th May' 2026' at 2:30 PM (Evening)
