ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Bajani Melo, Punli Village, Anini, Dibang Valley District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- Executive Engineer, Department of Power, Anini, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/12/2025 regarding replacement of damaged HT/LT pole and conversion of HTOH/LTOH with ABC under Dibang Valley District.

2). **The 1st hearing was held on 4th August' 2026.** Er. K.Loya, PIO-cum- Executive Engineer, Department of Power, Anini, Dibang Valley District, Arunachal Pradesh, was represented by Shri Tinku Das, HA, Department of Power, Anini, Dibang Valley District, Arunachal Pradesh. Appellant, Shri Bajani Melo, was represented by Adv. Dr. Bulia Pulu.

3). Adv. Dr. Bulia Pulu informed the Commission that no information had been furnished by the PIO with no justification for the delay.

4). Shri Tinku Das, HA, Department of Power, Anini, submitted that due to shortage of manpower in the division information could not be furnished to the Appellant within the prescribed time frame and that the issue had been informed to the Appellant. However, the APIO assured that information would be provided to the Appellant within the next 20 days.

5). The Commission admonished the APIO for a delay of over eight months and directed him to furnish authenticated, correct and complete information to the Appellant within 21 days from the date of issue of this order. The Commission also asked the Appellant to collect information from the APIO and intimate his satisfaction or dissatisfaction by 25th August'2026.

6). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission by 25th August 2026, the case would be disposed of.
