- h. Name of the tender board members with signature.
- i. Name of technical officer of site with their portfolio.
- j. No. of firms participants with their firm details and documents.
- k. Supplied all the documents with CTC
Period of which information asked: - 2022-23.

Order of the 5th hearing- *"The Commission has observed that the required information was already furnished to the appellant but the appellant could not apprehend the content of the information furnished to him and directed the appellant to attend the PIO's office in person within five days from the date of issue of the order wherein the PIO shall clarify and elaborate the information furnished to him. The PIO and appellant shall submit a written compliance report of this order to this commission within 10 days from the date of issue of this order."*

The following were present.

Appellant : Present through VC. He states that information received from the PIO is incomplete. He has submitted a letter dated Nil to the PIO informing about incomplete information.

Respondent PIO : Absent. Shri Taku Raji, APIO cum AE has represented the PIO. He states all information has already furnished to the appellant.

On interjection Shri Taku Raji, APIO stated that he was not aware of any reply furnished to the appellant against his written submission.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records observes that neither the letter submitted by the

appellant is clear as shortcoming information annexed is not as per his original Form – A nor the APIO is aware of appellant's representation.

The PIO is directed to respond to the appellant's representation within one week from the dated of issue of this order with a copy to this commission. The appellant is directed approach the PIO for further clarification.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. If no compliance report is received within stipulated time, this appeal case shall stand closed.
