SUMMON.

WHEREAS, in connection with the **APIC-No. 112/2025**, your personal appearance is required before the Commission on **20th January, 2026 at 01:30 PM**. The 3rd hearing held on **23rd Sept'2025**. The Appellant Shri Kamnga Ronya found absent during the hearing and the PIO-cum-DMO Daporijo Upper Subansiri District, Govt. of Arunachal Pradesh, also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is proffered against him as pwr the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

In the absence of both the **parties the Commission hereby observes;**

It is to be recorded that in the 2nd hearing on 31/7/2025 the Appellant stated that the PIO has provided all the information(s) sought in his form 'A' except the information(s) sought in Sl. No. (A) which is Answer Script /Answer sheet of all the selected candidates and waiting list are not yet been provided to the Appellant, despite the Commission order on 6th May 2025..

The PIO -cum-DMO Daporijo Govt. of Arunachal Pradesh was present in the 2nd hearing through online mode on 31/7/2025 and had agreed to provide the single information(s) which was yet to be provided to the Appellant.

In the absence of both the parties the Commission could not ascertain from the Appellant, whether he has been provided the impending information(s) or not.

Therefore, the Commission hereby orders;

- i) The Appellant to be present in the next date of hearing without fail, **failing which this appeal will be heard and determined ex-parte.**
- ii) The PIO--cum- DMO Daporijo, Govt. of Arunachal Pradesh, to be present in the next date of hearing, **failing which necessary action will be initiated against the PIO as per provisions of RTI Act 2005.**
- iii) To send the hearing notice to both parties to be present in the next date of hearing on 20/01/2026 at 1:30 PM.

The Commission hereby orders,

The next date of hearing be fixed on 20th Jan' 2026' at 1:30 PM (afternoon).


