Information sought:

The appellant filed an RTI application dated 04.09.2025 seeking following information regarding (i) 14th & 15th F.C. grant under untied and tied scheme and (ii) non-wages and wages under MGNREGA against of Tator-Taki III. GPC Segment at Riddi village under Circle Gusar.

1. Please furnish the true copy of up to date for release of total fund allocated and sanctioned order copy.
2. Please furnish the true copy of up to date for as per Administrative Approval order copy.
3. Please furnish the true copy of DPR/ Estimate for 14th and 15th F.C. grant of untied and tied schemes.
4. Please furnish the true copy of up to date for issue of work order by name of contractor. release of total fund allocated and sanctioned order copy.

5. Please furnish the true copy of up to date for as per administrative approval of NIT.
6. Please furnish the true copy of up to date for material received by name of contractor.
7. Please furnish the true copy of up to date of work-geo-tag photograph by name of work against.
8. Please furnish the true copy of up to date for work completion reported by name of contractor.
9. Please furnish the true copy of up to date for work progress reported by name of work and name of contractor list.
10. Please furnish the true copy of up to date for issue of cheque leaf xerox copy by name of work and name of contractor.
11. Please furnish the true copy of trading licence name record list copy.
12. Please furnish the true copy of how many issuances of material items against of each GPM segment received list copy.
13. Please furnish the true copy of up to date for UC reported by name of schemes against received list copy.
14. Please order to staffs and name of applicant is checking to site /spot and name of work inspection under section -J(2) of RTI Act-2005.

The following were present.

Appellant : Present. He states that FAA – Deputy Commissioner, Daporijo did not conduct hearing after summon notice issued for hearing on 10.2.2026. Till today he has not received information applied for from the PIO.

Respondent PIO : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the appellant and perusal of the records, observes that FAA has issued summon notice dated 02.01.2026 for hearing on 10.02.2026 but the judgement order is not on record. The absence of the PIO in today's hearing, without any intimation of reason thereof, is violation of statutory duty of a Public Authority in implementation of RTI Act.2005.

As laid down at para-38 of the Guidelines for the FAA issued by the GoI and the State Govt. OM No. AR-111/2008 Dated 21st August, 2008, adjudication on the appeals under RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.

Therefore, the instant appeal case is remanded to First Appellate Authority. Therefore, the **FAA – the Deputy Commissioner, Daporijo**, AP, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within two weeks from the date of receipt of this order.

The appellant is at liberty to file 2nd appeal afresh:

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
2. If the FAA has denied the requested information based on specific exemptions/ grounds provided under the RTI Act, 2005.

Fee for such 2nd appeal, if done, shall be exempted.
