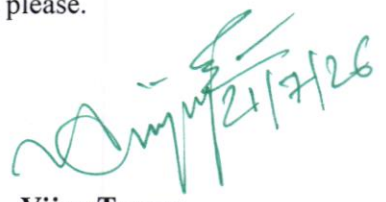

ORDER

The 2nd hearing held on 21st July' 2026 related to the APIC- No-933/A/2025. The Appellant Shri Buli Bhai is present during the hearing before the Commission.

The PIO-cum-Project Director (PD), DRDA, Raga, Kamle District, Govt. of Arunachal Pradesh, found absent consecutively for the second time without reporting the reason for his absence to the Commission despite hearing notice sent to him from the Arunachal Pradesh Information Commission (APIC) on 16.02.2026 and 07.05.2026.

Heard the Appellant;

The Appellant stated that he met the PIO at his office, wherein, the PIO assured to provide the information(s) through his Junior Engineer (JE), but neither the PIO nor the JE has contacted or provided the information to him till today.

After hearing the Appellant and seriously viewing the consecutive absence of the PIO in the hearing, the Commission pass the below orders:

- i) To issue **Bailable Warrant of Arrest** against the PIO-cum-Project Director (PD), DRDA, Raga, Kamle District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 22nd day of September' 2026 at 2:30 PM.
- ii) To issue order to the Officer-In-Charge, Raga Police Station, Kamle District, for executing the **Bailable Warrant of Arrest** and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **22.09.2026, at 2:30 PM, without fail**, before this court.
- iii) The copy of this **Bailable Warrant of Arrest** be served to the Superintendent of Police, Kamle District for compliance.
- iv) The copy of this **Bailable Warrant of Arrest** be served to the Deputy Commissioner, Kamle District for information.
- v) The Appellant to be present in the next date of hearing without fail, failing which the Commission will hear and determine this appeal ex-parte.
- vi) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 22nd day of September' 2026 at 2:30 PM (Evening).
