Subject matter of information required to be furnished: -

(1) DETAILED Copy of Demand Note for the demand of Fund for payments of the compensation amount against land acquisition as well as for the corridor of transmission lines, such copy of demand note as submitted by the entire District Administration (s) through any appropriate authority/agency entrusted thereon in the state of Arunachal Pradesh wherein the said project work is Ongoing or Completed.

Period of Information: 2023-24
