Information sought:

The appellant has filed an RTI application dated 05.10.2025 seeking following information regarding "C/ o Plan & Non-plan work/projects sponsored by State fund/Central fund or both such as SIDF / BE / RE / RIDF / SADA / ADA / MLALAD / MPLAD / SPA / Article275(1) / PMJVK / CRIF/PMDeVine/nec/nesids/Non-BADP/SASCI/JJM/NRDWM/SPM/Maintenance work etc. from the financial year 2025-16 to 2025-26.

Particulars of sought information are given below:-

1. Copy of Total List of Completed Projects/works (Plan & non-plan) in which the Security Deposits has been refunded to the contractors (submitted in FDR etc. and deducted from each running bill and final bill @2.5% minimum/7.5% maximum, of the gross amount of Bill) under the division for each financial year from 2015-16 to 2025-26 with proper date of completion details.
2. Copy of Total list of projects/works (Plan & non-plan) in which the Security Deposits has been on hold despite the completion of projects/work of each respective financial year from 2015-16 to 2025-26.
3. Copy of Register of Security Deposit Form CPWA 67 maintained in the Division for each financial year from 2015-16 to 2025-26 in respect of the subject mentioned above.

4. Copy of Refund of Security Deposit (along with supporting documents of refund) to the Contractors as per agreement made in Forms CPWD 7 & 8 on the completion of works regulated by Clause 17 of GCC in respect of serial no.1 mention above for each financial year 2015-16 to 2025-26.

5. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index, proper paging of each financial year and separate books for each financial year for easy & better understanding).

The following were present.

Appellant : Present. He states that the FAA has heard the first appeal and produced a copy of judgement order.

Respondent PIO : Present through VC. He states that xerox copy of information is kept ready for delivery.

F A A : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that FAA has heard the first appeal and passed a judgement order on 16.1.2026 and disposed of the first appeal. The PIO has stated in today's hearing that the Xerox copy of the information is kept ready for delivery to the appellant. The appellant shall collect the information from the PIO within two weeks and submit a status report to this commission within three weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
