An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-573/2025

Shri Bengia Papo -V/S- PIO-Cum-EE, UD & Housing, Koloriang, K/Kumey District A.P.

ORDER

The 1st hearing held on 4th Dec'2025, related to the APIC-573/2025. The Appellant's representative Shri Bengia Tahar present during the hearing.

The PIO-cum EE- (UD & Housi) Kolorinag Division present by the APIO Shri Bamang Amar, A E-cum APIO (UD & Housing) Kolorinag represent during the hearing.

Heard both the parties.

The Appellant stated that the PIO has not provided him the information as sought so far.

The APIO stated the information for which the Appellant has sought is still under progress only tendering part has been completed and the work is not started because the work will be taken up after the present old quarters of employees are dismantled.

Regarding the order of the First Appellate Authority (FAA) cum CE (UA) (UD) had order on 24/06/2025 the Appellant to be provided with the information as applied to which the PIO on 12/07/2025 and written a letter to the Appellant to deposit an amount of Rs 12,700/- (Rupees twelve thousand seven hundred) only being fees for furnishing relevant documents through Treasury Challan. But the Appellant has not complied with the order from the PIO till now.

The application of the Appellant was posted through registered post to the PIO, which reached office of the PIO very late as in Arunachal Pradesh, the postal services has very poor. And even before the form 'A' was received by the PIO. The Appellant had filed 1st appeal before the First Appellate Authority (FAA).

After hearing both the parties the Commission hereby observes;

i) The Commission order minutely observing that the Form 'A' of 1st the Appellant it is found that the Appellant has asked for information wherein he has no Locus Standii to ask for certain information because he not as interest party in it, as well as those information are sought are not in public interest.

The Commission here by order;

- i) That among all the information sought by the Appellant information as given in form 'A' of the Appellant in no. **1,5,8,13,14 & 25**, only are provided to the Appellant within 1(one) month from today.
- ii) The PIO, to provide all the information to the Appellant within 1(0ne) month from today, and the Appellant to collect the information from the office of the PIO in person. And the PIO to inform the Appellant as the information are ready to be furnished to the Appellant.
- iii) The PIO to attend the next date of hearing without fail. **Failing which, appropriate action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.**
- iv) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing without fail, **Failing which his appeal shall be heard and determined ex-parte.**

The Commission ordered;

The next date of hearing be fixed on 7th April'2026 at 2:30 PM(Afternoon).
