ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ratan Chetia, Village-Sitpani Moran, P/o, P/s Mahadevpur, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (WRD), Bordumsa Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 7/04/2025 regarding (i) Erosion management and protection work at Diyun, 2023-24, (ii) Construction and extension of MIC at Jyotipur Sompoi and Dumpari Diyun, 2023-24, (iii) C/o MIC at Dum Pather and Innao Pather, Diyun, 2023-24.
- 2). The 1st hearing was held on 20th January' 2026. The PIO-cum-EE (WRD), Bordumsa Division, Changlang District, Arunachal Pradesh was represented by Er. J. Sangno, APIO, through Video Conferencing. The Appellant Shri Ratan Chetia had also attended the hearing through Video Conferencing.
- 3). During the 1st hearing, the Commission had directed the PIO to furnish information to the Appellant within thirty days from the date of issue of the order dated 20th January'2026. The Commission had also asked the Appellant to visit the office of the PIO and collect information. The Appellant was also asked to intimate his satisfaction or dissatisfaction after receipt of information.
- 4). The Appellant vide letter dated 03/03/2026 informed the Commission that the PIO had not furnished complete information and appealed for a date of hearing.
- 5). The Commission directs the Appellant to submit the list of incomplete information to the PIO and collect the remaining information from the PIO before the next date of hearing.
- 6). **The next date of hearing is fixed on 14th July'2026 (Tuesday) at 11.00 AM.**
- 7).**Therefore,** The PIO-cum-EE (WRD), Bordumsa Division, Changlang District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.
- 8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
