ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, Naharlagun, PO/PS Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(RWD), Seppa Division, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 06/11/2025 regarding **C/o road from point 80 km Jayanti to Fangche-I & II.**
- 2). **The 2nd hearing was held on 25th August 2026.** Shri M. Riba, PIO -cum- EE(RWD), Seppa Division, East Kameng District, Arunachal Pradesh and the Appellant Shri Mamu Sono were absent.
- 3). The Commission, in view of the order dated 9th June 2026, decided to dispose of the Appeal. However, due to the absence of PIO and for want of a reply to the Show Cause Notice, the Commission decided to keep the case in abeyance till receipt of reply from the PIO.
- 4). The Commission, giving reasonable opportunity, hereby directs the PIO to reply to the Show Cause Notice before 20th September 2026, failing which, the Commission shall be compelled to invoke penalty under section 20(1) of the RTI Act 2005 and issue arrest warrant under section 18(3)(a) of the RTI Act 2005 for violation of the provisions of the RTI Act and non-compliance of the Commission's directions.
- 5). **Therefore, the case is kept in abeyance till receipt of reply from the PIO.**
