Information sought:

The appellant filed an RTI application dated 04.07.2025 seeking following information regarding W/C staff position under PHE & WS Seppa Division.

Details of information required:

- Category of work charged (W/C) serving under your division and sub-division.
- Appointment letter of all the W/C staff serving under your division and sub-division.
- Place of posting of all the W/C staff serving under your division and sub-division.
- Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.
- Present strength of W/C staff under your division and sub-division.
- New strength of or against retirement or vacate of W/C staff under your division and sub-division.
- Total sanction strength of W/C staff under your division and sub-division.
- Recruitments rule (RR) of W/C staff serving under your division and sub-division.

Period for which information asked for: - 2016 to till date

The following were present.

Appellant : Absent. He has requested the Commissioner to postpone today's hearing vide his letter dated 17.04.2026 due to his unavoidable personal work.

Respondent PIO : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, perusal of the records observes that the FAA – Chief Engineer (WZ), PHE & WS Department, Govt. of Arunachal Pradesh has heard the appeal case on 16.09.2025. He has passed an interim order with an advice to the PIO to furnish required information to the appellant but no timeline has been fixed.

Whereas, the FAA has not yet disposed off the first appeal, he is directed to get his order dated 16.9.2025 implemented by the PIO and pass a final judgement. Therefore, this appeal case is remanded to the **FAA - the Chief Engineer (WZ), PHE & WS** for final adjudication on first appeal within two weeks from the date of issue of this order.

The appellant is at liberty to approach this commission:


1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
