An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-873/2025.

APPELLANT : Shri Tamchi Gungte, near KV-II School Chimpu Itanagar,
RESPONDENT : The PIO, o/o the Director of TRIHMS, Nlg. (A.P)

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 4(four) point information in respect of "Establishment of New Medical college attached with District/ Referral Hospitals (Tomo Riba Institute of Health & Medical Science, Naharlagun" by the PIO, o/o the Director of TRIHMS Naharlagun (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.09.25:

This appeal was heard on 24.04.2026 and this Commission, upon hearing the parties, directed the PIO to furnish the requested information which were found not exempted under any of the exemption clauses of section 8(1) of the RTI Act, 2005 and to report the compliance therewith on **29.05.2026**.

On 29.05.2026, the PIO did not appear due to his pre-occupation in the ongoing inspection of the TRIHMS by the National Board of Examination in Medical Science (NBEMS). As such the hearing was adjourned to 08.06.26 and directed the PIO to be present with the in-charge of the accounts section as directed earlier. The hearing was, however, held on 11.06.2026 wherein the PIO, accompanied by the FAO, TRIHMS as well as the appellant were present.

In compliance with the order of this Commission in its order dt.24.04.26, the PIO brought in the left out information which were handed over to the appellant and vide order dt.11.06.2026, the appellant was directed to go through the documents/information furnished by the PIO and report the shortcoming, if any, thereon to this Commission within 2(two) weeks from the date of receipt of this order for further consideration of the appeal.

The appellant, vide his letter dt.13.07.2026 (as reproduced hereunder), has now complained that the PIO did not furnish the remaining documents/information as per his application and pleaded for direction to the PIO to furnish the remaining information.

"Respected Sir,

With utmost respect, I am writing to inform you sir that as per the hearing conducted at your chamber at 8th June, 2026, the PIO was directed to furnish the remaining document to the appellant. But, still I haven't receive any documents from the PIO. Therefore, I request the honorable Court to fix another date of hearing and direct the PIO to fix another date of hearing and direct the PIO to furnish the remaining documents.
