ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gunte for non-furnishing of 32 (thirty two) point information on C/o "Development of wayside Amenities at Tago Putu, Yazali, Keyi Panyor District" during the financial year of 2017-18 under NEC project by the PIO, o/o the Executive Engineer (RWD), Yazali Division, Keyi Panyor District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.05.2025.

This appeal was heard on 12.12.2025 wherein the appellant, Shri Tamchi Gunte and the representative of the PIO, Shri Bengia Chito were present in person.

The appellant then submitted that the PIO had earlier furnished some of the requested information/documents but he was not satisfied with the same. The representative of the PIO, on the other hand, submitted that the implementation of the project in question was initiated by the department of Tourism and therefore, the records were not available with the o/o the PIO (PWD, Yazali Division). He however, submitted that as records have now been handed over to the o/o the PIO, the requested information /replies are being furnished to the appellant vide letter dt.11.12.2025, a copy whereof is also endorsed to this Commission.

The documents so brought in by the PIO's representative were handed over to the appellant who was directed to go through the same and report his satisfaction or otherwise therewith to this Commission within 1(one)week for further consideration of the appeal.

In compliance with this Commission's order dt.12.12.2025, the appellant, vide his letter dt.19.12.2025, as extracted hereunder, has complained that the documents furnished by the PIO were incomplete:

"Respected Sir,

With due respect, I would like to inform you sir that the documents furnished by the PIO is incomplete as I have seek in my Form-A and I believe that the information I'm seeking doesn't fall under section 8 of the RTI act.

Following are details of the incomplete information as per my Form-A-

A) Serial no. 2: The document is not furnished.

B) Serial no. 5: The information is not furnished.

C) Serial no. 6:- did not furnish the documents.

D) Serial no.11: the documents is not furnished.

G) Serial no. 15:- the documents is not attached in NIT Copy therefore the documents is not furnished.

H) Serial no. 16:- the documents is not attached in NIT Copy therefore the documents is not furnished.

I) Serial no. 17:- No documents is furnished.

J) Serial no. 18:- No documents provided.

K) Serial no. 19: No documents is furnished.

L) Serial no. 20:- No documents is furnished.

M) Serial no. 21: No documents is furnished.

N) Serial no. 25:- No documents is furnished.

O) Serial no. 26:- No documents is furnished.

P) Serial no. 28:- No documents is furnished.

Q) Serial no. 29:- no information furnished

R) Serial no. 30:- no information furnished.

S) Serial no. 31: no information furnished.

Lastly, I would like to make a request your good office to fix an another date of hearing to hear the matter as I have not received the complete documents.

In view of the complaint of appellant as above, the PIO was directed to furnish the left out documents/ information to the appellant and report the compliance therewith to this Commission in the next hearing on 4th February, 2026. It was, however, made clear that if the PIO does not hold any of the requested information / documents, he shall declare so by way of an affidavit as mandated under section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

Today on 04.02.2026, appellant is present in person while the PIO is represented by Er. Rallo Bath, JE with the following left out documents/information as under which have been handed over to the appellant Shri Tamchi Gungte:

The representative of the PIO reiterated the submission made in the remarks column of the table above that some of the documents/information requested by the appellant are not traceable /available in the o/o the PIO. But it is the requirement of law under section -7(8)(i) of the RTI Act that when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction. And as mandated by section-18(3)(c) and under rule-5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the submission/reply of the PIO has to be declared/supported by way of an affidavit.

The PIO is directed to make an endeavor to collect the documents/information which are still in the custody of the Tourism department and furnish the same to the appellant and also furnish the required affidavit against those which are not traceable.

The PIO shall comply with the above direction within 3 (three) weeks from the date of receipt of this order and thereafter, the appellant after going through the information/documents furnished by the PIO today, intimate this Commission of his satisfaction or otherwise for further action.
