ORDER

The 2nd hearing held on 23rd day of July' 2026' related to the APIC No-592/A/2025.
The Appellant Shri Chungma Sangbia is present during the hearing before the Commission.

The PIO-cum-Director, SJETA, Itanagar, Papumpare District, Govt. of Arunachal Pradesh Shri Maryi Doyom is present during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the information applied have not been provided to him by the PIO till today.

Heard the PIO;

The PIO stated that as the Appellant has applied information for the projects under taken in four different districts, he has written to the executing agency/department to provide the information to him so that he can pass on the same information to the Appellant. After his letter to the particular district implementing agencies such as Changlang, Longding, Koloriang and Daporijo have provided the information but, as the copies of information(s) are too voluminous he could not bring it today in the court and request the Appellant to collect the information(s) from the office of the PIO.

After hearing both the parties, the Commission hereby order as follows;

- i) The Appellant to collect the information(s) from the office of the PIO and intimate the Commission, whether the information(s) provided are complete or not in the next hearing.
- ii) The PIO to provide the information(s) pertaining to the work executed under Dumporijo Division to the Appellant as soon as possible.
- iii) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the information(s) have been furnished to him completely by the PIO, and thereby, the Commission will hear and determine this appeal ex-parte.

- iv) The PIO to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- v) Notice for the next date of hearing need not be sent to both the parties, as both parties are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 1st day of October' 2026 at 10:30 AM (Morning).
