Information sought:

The appellant filed an RTI application dated 16.11.2025 seeking information related to Shri Bhupen Khamyang, EE since assuming the charges of EE PHE & WSD, Namsai Division.

Details of information required:

- Certified Copy of total expenditure since his assuming the charge of EE, PHE & WSD, Namsai Division.
- Certified Copy of all kinds of payment made from EE, PHE & WSD, Namsai Division.
- Certified Copy of all works i.e. Major & Minor Done/ongoing/completed since his joining as EE PHE & WSD, Namsai Division.
- Certified Copy of Work Charged (W/C) /Contingency/casual Staff recruited till date & existing number of vacancies generated till date by retirement, dead, resignation (All of its kind) by present incumbent EE PHE & WSD, Namsai Division.
- Certified Copy of Name of all works proposed & get Administrative Approval Accord (AA & ES).

- (f) Certified Copy of Note sheet/Recommendation/OM letter from Minister/Advisor to HM/MLA in favour of Shri Bhupen Khamyang AE PHE & WSD to serve as Officiating/Functional EE of PHE & WSD, Namsai Division.
- (g) Certified Copy of Order/OM from Commissioner/Secretary PHE & WSD, GoAP or CE(EZ) PHE & WSD in favour of Shri Bhupem Khamyang AE PHE & WSD to serve as Officiating/Functional EE of PHE & WSD, Namsai Division.
- (h) Inspection of Documents and Records Under Section 2(j) of RTI Act, 2005 to be assisted by concern PIO or APIO.

Period for which information asked for: - Since present incumbent assuming the charge of EE PHE & WSD, Namsai Division.

The following were present.

Appellant : Present through VC. He states that he has received the information but there is certain shortfall, so he is not satisfied with the information furnished to him.

Respondent PIO : Present through VC. He states that he assumed as Executive Engineer, Namsai PHE & WS Division on 02.07.2025 and the pertaining information of his period has been furnished.

On interjection the appellant said he has not received information as sought in serial no. (g) Certified copy of Order/OM from Commissioner/Secretary PHE & WSD or CE (EZ) PHE & WSD in favour of Shri Bhupem Khamyang AE PHE & WSD to serve as Officiating/functional EE of PHE & WSD Namsai Division and would like to inspect document as applied for at serial no. (h) Inspection of documents and records.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA cum Chief Engineer (E/Z) PHE & WS Department, Namsai has heard and disposed of the appeal case on 16.01.2026 with a direction to the PIO to furnish all the information sought to the appellant within 30 days from the date of issue of their order. The PIO has produced today, during hearing, a copy of information as sought at serial no. (g) Certified copy of Order/OM from Commissioner/Secretary PHE & WSD or CE (EZ) PHE & WSD in favour of Shri Bhupem Khamyang AE PHE & WSD to serve as Officiating/functional EE of PHE & WSD Namsai Division. (a copy enclosed).

The PIO is directed to facilitate inspection of documents as applied for at serial no. (h). The appellant shall inspect the document within one week from the date of issue of this order and submit a status report to this commission within 15 days from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
