**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Donik Roru & Shri Khyoda Tacha, Jully II Colony, PO/PS Itanagar, Arunachal Pradesh, for non-furnishing of information by Er. Rido Allo, PIO-cum-EE(RWD), O/o the Executive Engineer (RWD), Palin / Jamin Division, Kra-Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2025 regarding DC Untied Fund for c/o protection wall at Govt. Secondary School Lumba under Palin Circle of Kra-Daadi District 2022-23.

2). **The 1<sup>st</sup> hearing was held on 18<sup>th</sup> November' 2025 as scheduled.** Er. Rido Allo, PIO-cum-EE(RWD), O/o the Executive Engineer (RWD), Palin / Jamin Division, Kra-Daadi District, Arunachal Pradesh was absent. The Appellant Shri Donik Roru was present.

3). The Appellant submitted that the PIO had not furnished any information till date.

4). The Commission viewed the absence of the PIO, without any justifiable reason, seriously.

5). The Commission hereby directs Er. Rido Allo, PIO-cum-EE(RWD), O/o the Executive Engineer (RWD), Palin / Jamin Division, Kra-Daadi District, Arunachal Pradesh to **SHOW CAUSE as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005**, failing which disciplinary action shall be recommended under Section 20 (2) of the RTI Act, 2005.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance. In case Appellant is found absent the case shall be disposed of without any further notice.

7). The next date of hearing is fixed on 20<sup>th</sup> January 2026 (Tuesday) at 1100hrs.
