An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-430/2026.

APPELLANT : Shri Nabam Kakung, Bedhi-Bedha Vill. Itanagar.

RESPONDENT : The PIO, o/o the EE (RWD) Papum Poma Division, Yupia

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Kakung for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD) Papum Poma Division, Yupia as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 09.03.2026.

A) Particular of information: regarding o/o Industrial Shed at Chakma Block viii Chessa Funded From SIDF Acheme under Balijan Circle District Papum Pare, A.P.

B) Details of information required:

1. Furnish the guidelines for implementation of Infrastructure development fund from government of Arunachal Pradesh.
2. Furnish the technical sanctioned orders copy of construction of industrial shed at Chakma Block- vill Chessa Papum Pare
3. Furnish the detailed Project report/Drawing Designed of the said project.
4. Furnish the Notice inviting tender copy with date and published News Paper name.
5. Furnish the check list of total firms participated during the NIT.
6. Furnish the showing comparative statement of L, 1 L, 2 L, 3 of the bidders.
7. Furnish the name and details of the firm to whom the road project was awarded along with successful bidder tenders documents submitted viz(1) Contractor enlistment(2) Trading license (3) ST/PRC Certificate(4) GST along with latest 3-RB return filling copy(5) Aadhar Card(6) EPF with latest return filling copy
8. Furnish the Bill of Quantity (BOQ) of the winning firm.
9. The acceptance letter copy by the winning firm.
10. Furnish the Geo tagging copy of the three stages: - Before the project commenced, after the project started and after the completion of the project.
11. Furnish the Agreement copy between the executing agency and working agency for maintenance of the said project.
12. Furnish the total tender bidding amount.
13. Furnish the non-tendering work order issued if any?
14. Furnish the copy of counter foil of cheque/PMFS Generated print payment Advise copy in every payment.
15. Furnish the how many amounts has been deducted for TDS/GST viz, CGST/SGST/Income tax or others taxable etc. details please.
- (16) Furnish the utilization certificate of the said project along with audit report copy.

17. Furnish the measurement book of every bill paid for the said project along with first final bills form copy.
18. Furnish the approval letter by Chief Engineer RWD and the Superintending Engineer RWD of tender balance amount.
19. Furnish the copy of cost justification of balance amount/fund.
20. Furnish the whether the surrender amount has been utilized or deposited? If utilized provide the work order or tender or tender documents where the amount was utilized?
21. Furnish the status report copy cited project

Brief facts emerging from the appeal and decision:

The records in the appeal reveal that the appellant, Shri Nabam Kakung, vide his RTI application dt. 09.03.2026, had requested the PIO for the aforementioned information but failed to obtain the same which prompted him to file his 1st appeal before the Superintending Engineer, RWD, Itanagar Circle, Govt. of Arunachal Pradesh, Itanagar the First Appellate Authority (FAA) under section 19(1) of the RTI Act via his Memo of Appeal dt. 23.04.2026.

The records in the appeal, however, do not indicate as to whether the FAA had conducted the hearing and passed any order thereon but the appellant, vide his Memo of Appeal dt. 10.06.2026, has preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act, 2005 on the ground of non-furnishing of requested information.

This appeal is, accordingly, listed today on 02.09.2026 wherein the appellant, Shri Nabam Kakung is present in person while the PIO, Er. Ngurang Nyia, E.E is present through VC.

Heard the parties.

The PIO submitted that the requested documents are ready to be furnished to the appellant.

As assured to by the PIO, the appellant is directed to visit the office of the PIO and collect the requested documents within 1(one) week from the date of receipt of this order and intimate the receipt of the same within one week thereafter to this Commission failing which this appeal shall stand closed without further notice.

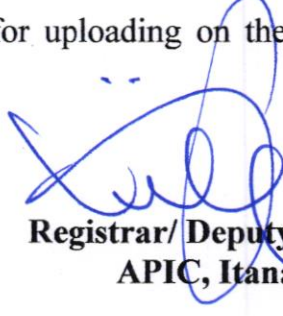
