**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO, O/o Directorate of Land Management, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/06/2025 regarding detail information of appointed Mandal, RK, & SK.
- 2). The 3<sup>rd</sup> hearing was held on 21<sup>st</sup> April'2026. Shri Tara Raji, , PIO-cum-ADLM, Director, O/o Directorate of Land Management, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms. Bengia Mama were present.
- 3). During the hearing, the Commission had asked the Appellant to peruse and verify the document. In case, any information were left out, she was asked to approach the PIO and get complete information. The PIO also was directed to furnish all information as required. In case, any information were not available in the office record, the PIO was to give justifiable reasons in writing. The Appellant was also asked to intimate his satisfaction or dissatisfaction after receipt of information.
- 4). The Appellant vide letter dated 07<sup>th</sup> May'2026 informed the Commission that the PIO had not furnished complete information and appealed for a date of hearing.
- 5). The Commission directs the Appellant to submit the list of incomplete information to the PIO and collect the remaining information from the PIO before the next date of hearing.
- 6). **The next date of hearing is fixed on 14<sup>th</sup> July'2026 (Tuesday) at 11.00 AM.**
- 7).**Therefore,** Shri Tara Raji, , PIO-cum-ADLM. Director, O/o Directorate of Land Management, Itanagar, Papum Pare District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
