<u>ORDER</u>

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (E) Roing Electrical Division, Distt. Lower Dibang Valley, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19.10.2024.

A) Particular of information: Construction of 11 KV line from Bizari and Anpum village in Lower Dibang Valley District, A.P. under SASCI – 2023-2024.

B) Details of information :

- 11. Certified Copy of Board Members of the Tender Processing.
- 12. Certified Copy of Bank Solvency Certificate of the Firm who did the work/scheme.
- 13. Certified copy of Affidavit of having not more than 2 (two) work in hand under the State Govt. by the firm.
- 14. Certified Copy of GST registration certificate, Income tax clearance certificate latest Audit report of last 3 (three) years duly certified/Audited by the Chartered Accountant the Firm who did the Work/ Scheme.
- 15. Certified Copy of Measurement Book of the said work.
- 16. Certified Copy of First and Final bill of the said work.

- 17. Certified Copy of Cash Book Statements with page numbers or Give hand receipt with Payee name of the said work.

This appeal is listed for hearing today on 09.07.2025 for the 2nd time, the earlier hearing being on 4th June, 2025 wherein the appellant, Shri Chow Lajamang Mannow was present but the PIO was absent without any information.

This Commission heard the appellant who submitted that he had received most of the requested documents / information from the PIO as per his application except the following :

- a) Certified Copy of Bank Solvency Certificate of the Firm who did the work/scheme.
- b) Certified copy of Affidavit of having not more than 2 (two) work in hand under the State Govt. by the firm.
- c) Certified Copy of Cash Book Statements with page numbers or Give hand receipt with Payee name of the said work.
- d) Certified Copy of Photograph with Global Positioning System (GPS) Coordinates/Geo-tag of the said work, before starting and after completion of the said work/scheme.

This Commission noticing that the work in question has since been completed, the queries at Sl. No. (a) and (b) became redundant and hence not necessary, the appellant was suggested not to insist on the same which he agreed to in respect of (a) but insisted for the documents at Sl.(b),(c) and (d) leaving and pleaded for direction to the PIO to furnish the documents.

This Commissioner considered the plea of the appellant and accordingly, directed the PIO to furnish the said left out documents/information to the appellant within one month, in any case on or before 09.07.25, the next date of hearing.

The appeal is, thus, listed again today on 09.07.2025 wherein both the PIO, Er. Shri Jitu Miri, E.E and the appellant, Shri Chow Lajamang Mannaw appeared through VC.

The appellant submitted that he had received the left out documents but did not receive the photograph of the project after the completion of the project.
