Information sought:

The appellant has filed an RTI application dated 10.11.2025 seeking following information regarding selection details under DDUSY 2025-2026 Kurung Kumey District.

Details of information required;

1. Provide the final list of selected candidates under DDUSY 2025-26 along with their application numbers and addresses.
2. Provide copies of all documents submitted by selected candidates, including: a) a. Unemployment Certificate/Undertaking attested by Notary/Executive Magistrate. b) Permanent Residence Certificate (PRC).c) ST Certificate. d) Proof of Identity (Aadhaar/Voter ID, etc.) e) Proof of Business Address (Trading License, GST Registration, etc.). f) No Dues Certificates from Co-operative Apex Bank and State Bank of India.
3. Provide copies of PowerPoint Presentations (PPTs) or any other materials submitted by selected candidates during the Viva Voce/Presentation before the District Level Selection Committee (DLSC).

4. Provide the attendance sheet and marks/evaluation record maintained during the presentation round.
5. Provide the videography record maintained during the presentation round.
6. Provide the field verification report (Phase-II) of selected candidates and names/designations of the officials who conducted it.
7. Provide details of any Government-employed or self-employed candidates found among the selected list, with reasons for their selection.
8. Provide details of any candidates whose documents were incomplete, missing, or unverified, and specify whether their applications were still accepted.
9. Provide a certified copy of the District Level Selection Committee (DLSC) meeting minutes where the final list was approved.
10. Provide the criteria, scoring pattern, or evaluation method used by the DLSC during the selection process.
11. Provide the names and designations of DLSC members who approved the selection list.
12. Provide clarification on whether women beneficiaries are eligible for an additional 5% interest subsidy annually, and how it is implemented.
13. Provide details on how preference was granted to candidates having Degree/Diploma/ITI in relevant trades as mentioned in the official advertisement.
14. Kindly inform whether there is any reservation, quota, or relaxation under DDUSY 2025-26 for persons with disabilities (PwD/Divyang category) in Kurung Kumey District.
A) If yes, please provide:
I. A copy of the Government notification/order or guideline that authorizes reservation or relaxation for PwD/Divyang beneficiaries under DDUSY 2025-26; and
ii. The names and details of all PwD/Divyang applicants who were selected under DDUSY 2025-26, along with their application numbers, project details, and copies of their PwD/Divyang certificates submitted during verification.
B) If No, kindly state the reason for non-implementation of the reservation as per the Rights of Persons with Disabilities (RPwD) Act, 2016, which clearly mandates that: Every Government scheme relating to employment, education, or skill development shall provide at least 4% reservation for persons with benchmark disabilities.
15. Provide a certified copy of the complete DDUSY 2025-26 Guidelines / Scheme Document / Implementation Manual issued by the Government of Arunachal Pradesh or by the Deputy Commissioner, Kurung Kumey District.
16. Please ensure that all the provided documents are detailed as per the RTI Act, 2005, clearly mentioning the serial number of each attached page, along with the name and title of each document attached or provided.

The following were present.

Appellant : Present. He states that the PIO has not furnished the information as per direction of FAA's order dated 18.03.2025.

Respondent PIO : Present. She brought the information document at Sl.no. 4 & 11 today in the court. She has requested for 2 weeks time for furnishing the information sought by appellant at Sl no.2 (b), (c), (d) & (e).

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA – Deputy Commissioner, Koloriang

has heard and disposed of the appeal case on 18.03.2026 with a direction to the PIO to furnish the requested information i.e Sl. No. 4. of the RTI application relating to the gross marks scored by all candidates and SL. No. 11 relating to the order containing the composition of the District Level Selection Committee (DLSC) may be provided to the appellant as per provision of Section 8(j) of RTI Act 2005. The FAA's judgement Order is upheld. The DLSC is constituted with designated officer by default provided in the guidelines for DDUSY which was provided to the appellant.

If the beneficiary candidates have submitted the information documents sought at RTI application serial at Serial no.2 (b) (c) (d) and (e) to avail government scheme under DDUSY 2025-26, then there is public interest in it. The PIO is directed to furnish the remaining information sought at Sl no.2 (b), (c), (d) & (e) within 2 weeks from the date of issue of this order to the appellant under intimation to this commission. The appellant is directed to collect the additional information from the PIO and submit a written status of it to this commission within three weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

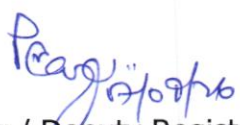
