**ORDER**

The 1<sup>st</sup> hearing held on 26<sup>th</sup> May' 2026' related to the APIC No-151/A/2026. The Appellant Shri Bachunum Yun is present through online mode during the hearing before the Commission.

The PIO-cum-EE, PWD, Tezu Division, Lohit District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has provided the information pertaining to the Serial Nos. A, B, C, H, I & J but the information(s) for the Serial No. E, F, G & K are yet to be provided to him.

**Heard the PIO;**

The PIO stated that the information for the Serial Nos. D, E & F are only available with the Superintendent Engineer (SE), PWD, Tezu Circle and not available with his office, and therefore, he has written to the Appellant regarding the same that the information are not available at his office. And regarding the information sought under Serial No. G the Appellant has asked for WC establishment rules which are already provided to the Appellant in the information for appointment orders of the WC staffs, and regarding the information for the Serial No. K the information will be compiled and provided to the Appellant and sent to him at his address as given in the Form-A.

After hearing both the parties the Commission hereby orders;

- i) The PIO to provide only the information sought by the Appellant in his Serial No. K of the Form-A on or before the next date of hearing.
- ii) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that he has got the information from the PIO, and thereby, this appeal will be disposed of.
- iii) The PIO to be present in the next date of hearing to ascertain from him whether he has provided the above mentioned information to the Appellant or not and in the failure of the PIO to be present in the next date of hearing the Commission will initiate necessary action against the PIO as provided under RTI, Act, 2005.

- iv) The information provided to the Appellant pertaining to Serial No. K of the Form-A of the Appellant should be appended with a covering letter from the PIO sealed and signed by him and addressed to the Appellant.
- v) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 4<sup>th</sup> day of August' 2026 at 2:30 PM (Evening).**
