Information sought:

The appellant filed an RTI application dated 10.06.2025 seeking following information regarding Land Compensation for C/o Road from KM 55.725 to KM 113.250 (Package-3) of Huri-Taliha Section of NH-913 (Frontier Highway) to Intermediate Lane or EPC Mode in the State of Arunachal Pradesh."

ii) Details of information required:

- Furnish the sanction order copy for Land Compensation Package-3.
- Furnish the all-compensation beneficiary list.
- Furnish the payment details of every compensation beneficiary.
- Furnish the M.B. Records.

- e) Furnish the Muster Roll records.
- f) Furnish the Guidelines of Compensation.
- g) Furnish the rate of quality/land trees etc.
- h) Furnish the color photographs of every individual.

Appellant : Present. He states that the PIO has not furnished any information to him.

Respondent PIO : Absent. Shri Jundo Karbak and Shri Deke K (Mandal) represented the PIO. They have stated that whatever information available with them have already been sent to the appellant through postal service. They brought a copy of the information document.

On interjection and quick view of the information by the appellant, the information against serial no. (C): "Payment detail of every compensation beneficiary" was incomplete.

FAA : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that FAA – Deputy Commissioner, Kara-Dadi district has not heard the first appeal filed to him. The representative of the PIO has brought a copy of the information today during the hearing which shall be handed over to the appellant.

The PIO is directed to furnish the information under serial no. (c) of the RTI application: the amount of compensation paid to each beneficiary to the appellant within two weeks from the date of issue of this order.

The appellant is directed to submit a written status report about information received from the PIO within three weeks from the date of issue of this order to the PIO with a copy to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.
