ORDER

The 1st hearing held on **24 February' 2026'** related to the **APIC No-749/A/2025**. The Appellant Shri Lokam Namdu is present during the hearing before the Commission.

The PIO-cum-DCF, office of the PCCF, Shri Bijoy Pradhan, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is present during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not been provided with the information(s) till date.

Heard the PIO;

The PIO stated that the information(s) available with the PIO as sought by the Appellant have been provided to him through registered post on 19th day of May' 2025 but the envelope with the information(s) returned from the postal department stating the reason as "insufficient address" of the Appellant. Therefore, he could not provide the information to the Appellant till today.

One part of the information is not available with the office of the PIO, therefore, he has forwarded the application of the Appellant to the DFO Banderdewa who is the competent authority to provide the information(s) and he do not know whether the DFO Banderdewa provided the information or not.

The information(s) with the PIO have been provided to the Appellant in the court of the Commission today.

After the above stated statements from both parties the Commission hereby order as follows;

- i) The Appellant to go through the information(s) provided by the PIO and intimate the Commission the receipt of the information(s) completely or not in the next date of hearing.
- ii) Regarding the part of the information(s) to be obtained from the DFO Banderdewa, the Appellant is order to approach the DFO Banderdewa for the same.
- iii) The PIO to be present in the next date of hearing to verify from the Appellant whether the information(s) as furnished are complete or not.

- iv) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- v) Notice need not be send to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 14th day of May' 2026 at 10:30 AM (Morning).
