## **ORDER**

- The Appellant to be present in the next date of hearing without fail. V)
- vi) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The next date of hearing be fixed on 16 October, 2025' at 10:30 AM (Morning).
