**ORDER**

The 1<sup>st</sup> hearing held on **24 February' 2026'** related to the **APIC No-747/A/2025**. The Appellant Shri Lokam Namdu is present during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that he has not been provided with the information(s) till date.

**Heard the PIO;**

The PIO stated that the information(s) have been furnished to the Appellant through electronic media i.e Whatsapp at the mobile telephone number given by the Appellant in PDF form by his APIO.
