Information sought:

The appellant has filed an RTI application dated 06.10.2025 seeking following information regarding "C/ o Total list of completed Plan & Non-plan work/projects sponsored by State fund/Central fund or both such as SIDF / BE / RE / RIDF / SADA / ADA / MLALAD / MPLAD / SPA / Article275(1) / PMJVK / PMDeVINE / NEC/NESIDS/Non-BADP/SASCI, Maintenance work etc. from the financial year 2019-20 to 2025-26.

Particulars of sought information are given below:-

1. Copy of Total list of works/projects (Plan & Non-plan) executed under the division, under various scheme head mentioned above along with the details of cost of each project for each financial year from 2029-20 to 2025-26.
2. Copy of Sanction order/ Administrative Approval (AA) & Expenditure Sanction (ES)/ Administrative and Sanction (AFS) of each completed project in respect of serial no. 1 mentioned above for each financial year from 2019-20 to 2025-26.

3. Copy of Technical Sanction (TS) of each completed projects in respect of serial no. 1 mentioned above for each financial year from 2019-20 to 2025-26.
4. Copy of Agreement (in affidavit form) made between the Contractor and Executing Agency, for each completed projects/works in respect of serial no. 1 mentioned above from the financial 2019-20 to 2025-26.
5. Furnish the certified copy of Work Order (with amount mentioned) issued to the contractor with respect to serial no. 1 above. (only for the works/projects awarded in work order system) 2019-20 to 2025-26.
6. Furnish the Details of fund Surrendered to the Govt. Head Account, in respect of serial no. 1 of my form-A:
 - a. Remaining balance amount after A/A E/S and TS has been done. (Enclosed the proof of surrender such as Challan copy or whichever method has been used.)
 - b. Remaining Balance amount after TS and Contract Agreement of the project/work. (Enclosed the proof of surrender such as Challan copy or whichever method has been used)
7. Furnish the Details of Expenditures of fund if been utilized, in respect of serial no. 1 of my Form-A: -
 - a. Remaining balance amount after A/A E/S and TS has been completed. (Enclosed the proof of Expenditure.)
 - b. Remaining Balance amount after TS and Contract Agreement/work order amount of the projects/works. (Enclosed the proof of expenditure)
8. Furnish the certified details of Officer (name & Designation then & now) who authorized/approve the surrender process of fund in respect of serial no. 6 of the Form-A.
9. Furnish the certified details of Officer who authorized/approve the expenditures of fund in respect of serial no. 7 of Form-A.
10. Furnish the Rules followed by the concern Officers (under CPWD works manual/ any other etc.) that authorize the officers to make an expenditure of fund beyond the Contract agreement/Work Order amount in respect of the projects/works.
11. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index, proper paging of each financial year and separate books for each financial year for easy & better understanding).

The following were present.

Appellant : Present. He states that neither FAA has heard the first appeal nor the PIO has furnished any information so far.

Respondent PIO : Absent.

F A A : Present through VC. He states that hearing of first appeal was held on 21.04.2026 wherein the PIO was present but the appellant was absent. A copy of judgement order given to the appellant today.

On interjection, the FAA- Chief Engineer, HPD, Eastern Zone, Tezu states that the PIO could not attend today's hearing due to recent demise of his mother and that he has directed PIO to furnish the information sought to the appellant.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA has heard the first appeal on 21.4.2026 passed

an ex parte judgement order in absence of the appellant and given direction to the PIO to furnish information on filing of fresh application by the appellant. But today during hearing proceedings the FAA categorically stated that he has directed the PIO to furnish the information to the appellant as applied for. The PIO is directed to furnish the information to the appellant within two weeks from the date of issue of this order under intimation to this commission. The appellant shall serve a copy of this order to the PIO, obtain written acknowledgement and submit a copy of it to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

Order pronounced in the Open Court of this Commission today this 3rd day of August' 2026. Each copy of the Judgement / Order be furnished to the parties.
