ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri John Tara Bakey for non-furnishing of below mentioned information by the PIO, o/o the Deputy Commissioner, Yachuli, Keyi Panyor District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19.05.2025

(a) Particulars of Information: - Gun License issued since 30.07.2017 to till date.

(b) Details of information required:

1. Furnish the copy of name of the applicants for issuing of Gun License from 30.07.2017 to till date.
2. Furnish the copies of total numbers of Gun Licenses issued to the applicants from 30.07.2017 to till date.
3. Furnish the copies of Gun Licenses number, if any gun licenses from 30.07.2017 to till date.
4. Furnish a copy of any revocation order of issued of gun license banned by previous, if so.
5. Furnish copies of purchase cash Memo of the licenses holder deposited at DC, office.

(c) Seeking period from: 30.07.2017 to till date.

Records reveal that the Appellant did not receive the aforementioned information sought by him from the PIO in view of which he approached the F.A.A, the Deputy Commissioner, Yachuli, Keyi Panyor District, Govt. of A.P, under section 19 (1) of the RTI Act vide his Appeal Memo dated 27/06/25. But the appellant, apparently, failed to obtain the requested information or any response from the FAA. Hence, this 2nd appeal before this Commission under Section 19(3) of RTI Act, 2005, vide his Memo of Appeal dated 29.07.25.

This appeal was, accordingly, heard on 24.09.25. But none of the parties appeared despite summons notices.

The hearing of this appeal was, therefore, adjourned to today on 29.10.2025.

The appellant, Shri John Tara Bakey is present in person while the PIO is represented by Shri Taba Tahin, Statistical Officer and Shri Harshdeep, under trainee C.O, o/o DC, Keyi Panyor, Yachuli.

Heard the appellant, who reiterated his demand for the information/documents as sought for by him in his RTI application.

Also heard the representatives of the PIO who submitted that no new gun license has so far been issued by the o/o the DC, Keyi Panyor District which was constituted in the year 2023. They, however, admitted that applications for gun license were received by the District administration. In this regard, they also brought in the Registrar containing the list of the applicant who had applied for the gun license. On being queried, the representatives replied that the Register contains details of around 2000 applicants which was not possible to get xeroxed.

This Commission holds that the information /documents sought for by the appellant are not exempted under any of the exemption clauses under section 8(1) of the RTI Act, 2005 and as such the PIO is directed to get the list containing the names of applicants for gun license typed from the register and furnish the same to the appellant. The PIO shall also furnish the information/replies to other points serially in tabular form with specific reasons.

The PIO shall comply with the above direction within 1(one) month from the date of receipt of this order with intimation to this Commission. The appellant is also directed to intimate this Commission of the receipt of the information/replies within one month failing which this appeal shall stand closed without further notice presuming that he has received the requested information and is satisfied therewith.
